1,541 people turn up at the polls

This may be proclaimed in history as one of the most wellattended presidential race. Terry Miller, Cheyenne County election officer, reported at the close of the advance voting on Monday, 29 percent of the people had voted. Of the 1,985 registered voters in the county, a total of 572 had already shown up at the polls.

On Tuesday, the final total showed 1,541 people voting. Mr. Miller said 78 percent of the registered voters had

turned out for the election. In Cheyenne County, John McCain came out ahead. His strong opponent was Barack Obama. However, the final national vote for president was not known at the time the pa-

per was sent to the printer. In the local race for county commissioner of District 2, Dale Patton was the winner over incumbent Ray Lee. The rest of the local races were unopposed.

In St. Francis, the \$2.5 million bond to build a new gymnasium was voted down. Following are the results of



City recovers overpaid taxes

was pleased to hear that the city clerk had been able to recover overpaid sales tax.

Tabetha Ketzner said she was able to recover over \$3,500 in overpaid sales tax on water usage for the past 36 months for Bird City. The city did not charge this water usage tax to the residences.

Councilman Frank Serrano asked if a refund would be given out to the residents. He was informed that, unfortunately not, because it came directly out of city funds.

City hall improvement update

Councilman Wade Carmichael brought members updated information on city hall improvements and price quotes. He reported that improvements might exceed the \$20,000 budget.

The consensus of the members was the project should be completed. Mrs. Ketzner said she had a visitor who took pictures of the outside of the building and commented on what a unique building it was.

The cost-to-date on items such as replacing all the inside doors, electrical wiring including new light fixtures, sheriff office, tiling and carpet amounts to an estimate of \$24,000. The amount does not take into consideration labor costs from contractors, or that Craig White and Brad Schneider, city maintenance personnel, would be doing some of the work.

Kari Gilliland, city attorney, said the project should progress to create a city pride in what is happening at city hall. Mayor Burr had no complaints in keeping the project going. The council approved the improvement proposal

Councilman Carmichael added the projected completion date would be May 1. Mayor Burr asked to plan another update in January.

Wastewater lagoon project

Don High, Miller and Associates, requested payment for October's work. He reported that the retaining fee had been dropped from 10 percent to 5 percent, which is standard. He added they never drop the amount lower than it would be to hire another contractor to do the job.

The council approved the amount of \$67,693 paid to BSB Construction and \$7,047 paid to Miller and Associates.

City business updates

Information on the bids for the Emergency Medical Service training room was brought before the council member by Mrs. Ketzner. She reported that she has not received any bids from contractors.

It was approved for her to buy a display ad and use Mile Saver Shopper to increase the advertising area.

Bids on salvage items closed with the council accepting bid of \$700 from Francis Wahrman.

Council approved two to one for \$2,500 to repair and add insulation in the Van Doren Park restrooms. Councilman Frank Serrano voted no.

Councilman Loren White returned with a bid on a 75horse powered tractor. A new John Deere would be estimated \$40,000 and a discussion over buying a used one and its problems. Councilman White also brought bids on a lawnmower for the wastewater lagoon. It had been previously agreed by the council the Grasshopper would not be able to do the job. The bids ranged from \$8,000 to \$12,000.

Craig White, city maintenance, reported that gravel will be applied to side streets soon. Mayor Burr asked if there was still enough money to do the job. Mr. White said \$1,600 has been used from the approved \$10,000 budget.

Miscellaneous items In other business:

• The Cheyenne County Sheriff's Department will submit the 2009 contract at next meeting and include the 5-percent increase that was already approved in the budget.

• A letter of resignation from Angel Pham as relief city clerk was accepted.

• A building permit approved for Dennis Whitmore to build a garage.

· Linda Schneider apologized to Craig White for a recent incident at city hall involving her telling Mr. White she did not appreciate him warming up in the office while her husband, Brad, worked in the cold and if her husband got sick, she would not be happy. Mr. White accepted the apology.

• Mr. White and Mr. Schneider will be inspecting construction areas on building permits for possible utility lines.

• It is important to note that city hall will be closed on Friday as Mrs. Ketzner, will be attending a seminar for clerks.
