

# Win or lose the Cheylin junior high Lady Cougars play hard

On Jan. 21, the Grinnell-Wheatland Thunderhawks came to McDonald to take on the junior high Lady Cougars. The B-team played first and since the team had played them earlier in the season, they knew it would be a tough game. The Cougars started off slow, but as the game continued, they slowly fought back.

At the end of the first quarter, the Cougars trailed 0-11. By half-time, the score was 8-16. At the end of the third quarter the Thunderhawks extended the lead to 33-10, but near the end of the game the Lady Cougars came back, but fell short 23-34.

Allie Frisbie led the Cougars with nine points and had three rebounds and two steals. Elizabeth Keltz added seven points with five rebounds. Mary Anne Orten put in four points and had three rebounds and four steals.

Diana Garcia also scored three points and had two rebounds and three steals. Kalin Ritchey had three steals and Vaneza Castillo had two. Jaime Davison and Danae Magnani both grabbed three rebounds, while Elsa Craig Burr also had three rebounds and two steals.

"The Lady Cougars improved to shooting 27 percent, but had 50 turnovers in the game. That is something that we must improve upon!" said Coach Dan Carson. "The hustle was there, but we can't turn the ball over that many times."

### A-team

In the A-team game, the Lady Cougars also came out ready to play. At the end of the first quarter, the score was 3-11 in favor of the Thunderhawks. By half-time, they had extended their lead to 8-24.

The second half was even, with both teams scoring eight points in the third and 12 points

in the fourth. The final score was Cheylin 28, Grinnell-Wheatland 44.

Shayla Hubbard led the Cougars with 10 points, five rebounds and six steals. Allie Frisbie scored eight points with three rebounds and two steals. Susannah Jones added six points, six rebounds and three steals.

Orten also had four points and two steals. Ellie Pochop got two rebounds while Davison got five.

"The score didn't turn out like we would have liked, but we sure saw a lot of effort and fight in our team," said Coach Carson. "Hopefully we will improve upon our 21 percent shooting in the future. We were very pleased at the play of the ladies tonight. Some foul trouble in the first half really hurt, but again, they never gave up."

### Sharon Springs B-team

On Jan. 26, the Cougars played their make-up game with the Sharon Springs Wildcats. The B-team played first. This was the second match between these two teams. In the first meeting, the Cougars won 16-9.

The score by quarters was led by the Lady Cougars; 6-2, 10-4, 14-6, and the final score was 16-14. Frisbie, Diana Garcia and Danae Magnani all led the scorers with four points each. Keltz and Vaneza Castillo both had two points each.

With rebounds, again it was pretty evenly distributed as Orten, Davison and Magnani all grabbing four rebounds. Ritchey and Castillo both had three, and Garcia and Kelsey Miller each had two.

Keltz had six steals, Orten had five, Ritchey had four and Frisbie and Garcia each got two. It was a very balanced game and the girls really hustled well.

"They improved with only

30 turnovers, but still we need to get that number down," said Coach Carson. "We only shot 18 percent, but the girls found a way to win. This was an exciting win for us."

### A-team

In the A-team game, as the Cougars took to the court, they remembered the 29-21 loss in the first game of the season. From the very beginning of the game, the Cougars took charge and never let the Wildcats get anything started.

The score at the end of each quarter was 11-2, 19-4, 25-10, and the final score was Cheylin 38, Sharon Springs 18.

Jones led Cheylin with 17 points, Hubbard added nine points, Frisbie and Orten both put in four, and Pochop and Ritchey each added two. Jones got nine rebounds, Frisbie had four, Hubbard had three with two steals. Pochop, Ritchey, and Orten all had two, with Ritchey getting two steals.

"This was also a very exciting win for us. The ladies shot better with 38 percent and they played a very good game," said Coach Carson. "We were able to change defenses often to keep the Wildcats from getting much going."

one rebound, one steal and three assists. Cassie Rucker had one rebound, and Carmichael had two assists

"The girls provided a great game to watch," said Coach Deb Pochop. "It was a super team effort and everyone contributed. We look forward to two more wins this week!"
