- may have different symptoms: • Babies may be cranky and refuse to eat. They may have a rash. They may cry when held.
- Young children may act like they have the flu. They may cough or have trouble breathing.
- · Older adults and people with other medical problems may have only a slight headache and fever.

It is very important to see a What are the symptoms? The medical provider right away if you or your child has these symptoms. Only a medical provider can tell whether they are caused by viral or bacterial meningitis. And bacterial meningitis can be deadly if not treated right away.

> How is meningitis diagnosed? Your medical provider will ask questions about your health, do an exam, and use one or more tests. Lumbar puncture is the most important lab test for meningitis. It is also called a spinal tap. A sample of fluid is removed from the spine and tested to see if it contains organisms that cause the illness. Your medical provider may also order other tests, such as blood tests, a CT scan or an MRI.

How is is treated?

Treatment depends on the case. See your medical provider right away if you or your child has symptoms, because bacterial meningitis can be deadly if not treated right

Bacterial meningitis is treated in a hospital. You or your child will get antibiotics. And you will be watched carefully to prevent serious problems such as hearing loss, seizures or brain damage.

The meningitis vaccine is recommended for children and adolescents 11 through 18 years of age and is available in the Cheyenne County Health Department and Cheyenne County Clinic. The vaccine is recommended for other people as
