

It hardly seems possible that we our district is taking for the future. are only four weeks away from the end of the school year. It has gone by fast and we have had many success stories during the year. As I am completing my first year at Cheylin Schools, I would like to say "Thank You" to the students, staff, and community for helping make this a very successful year for our school and for Emily and me.

Spring is a very busy time of year. It is always interesting that during basketball season, we hear comments that some cannot wait until the season is over so things will slow down! They never seem to slow down, they just shift gears to other events. We have already hosted a home track meet and attend various others. Our golf team has participated in multiple meets as well.

Spring is a time of year when our music program has their Kansas State High School Activities Association state competitions. Our band and vocal students attended regional solos and small ensembles in Oberlin on March 27. We had six students qualify for state music in Wichita. They were Stephanie Busse, Naomi Reeh, Heath Antholz, Noah Jones, Max Hengen and Grant Shrader. In addition to these state qualifiers, our band received a I rating and our vocal received a II rating at Kansas State High School Activities Association large group in Colby on April 15. Congratulations to all these students and to Mrs. Hengen on their accomplishments.

At the April Cheylin Board of Education meeting, many items were discussed about the direction of our district as far as budget reductions are concerned. No official action was taken on any of the items that I am about to mention, but information will be presented as a direction

We are planning on moving junior high sports practice time during school time and not have the sixth through eighth grade students practice after school. Getting home at 7 p.m. makes a very long day for our junior high students and hopefully this will help with getting homework and assignments completed. The negative is the shorter practice time and scheduling but I feel we can work this out for our students

We are only planning on hiring assistant coaches for sports that have 13 or more students. If the number of participants are 12 or fewer, we will only hire one coach unless we have a team with the opposite gender head coach, then we will hire a second coach for that team. Also, we presently have three coaches for our high school football program and plan on reducing this number to a head and one assistant.

We are not planning on having cross country or golf next year. This was a very difficult direction for our board to pursue, but felt we could save additional money in these two areas. We have already combined the cheerleading and dance teams under one salary but may still have both programs through the cooperation of the sponsors.

The board of education would like to offer an option if individuals or organizations come forward and are willing to fund a program or coaching positions we may reinstate some of the cuts. The board still retains all rights to make decisions regarding any supplemental programs offered at Cheylin Schools. It is possible to reinstate the positions or programs if enough funding comes forth to cover salaries, entry fees, travel, and

We have a great venue in place to accept donations to help our school and our programs. Donors may make a direct tax deductible contribution to the school to support these or other programs. A more preferable method is to make a tax deductible donation to the newly formed Cheylin Schools Foundation through the Century II Foundation. Century II has agreed that 100 percent of the donations given for the school will go to the school and none of the money will be withheld for administrative fees. We are fortunate to have the help and support of Century II. Donations can be made either for a specific purpose or for the general use of our school programs.

We have made many moneysaving decisions at this time without hurting programs or staff associated with our academic programs. We hope we are able to maintain what we have in the future for Cheylin Schools. If parents would like to be available as a helper in case we need additional supervision at practice, please contract the school.

On a more positive note; the representative from our Kansas State Department of Education that visited Cheylin to watch our state testing told me after his visit "If every school in the state of Kansas did as well with their testing practices as Cheylin Schools, there would be no testing problems in the state." Congratulations to our students and staff for a job well done.
