Board agrees to purchase equipment

The preferred monitor cost \$20,000 with a \$2,000 cost each year for maintenance. It can monitor 30 different sensors including refrigerators, the therapy pool and blood banks, just to name some. Other monitors ranged from \$27,000 to \$33,000.

Jerry Toler, president, said he was concerned about liability issues that could occur without the monitor.

Paying for the monitor was a problem since it had not been budgeted for. Some of the memorial funds had been given to be used specifically for a certain project. However, there was enough money in the fund without using the specified money to purchase the monitoring system. The board voted to purchase it with memorial funds.

Tax credit

The hospital was recently awarded a tax credit for the purchase of a new CAT scan. The tax credit is for \$300,000 and individuals will receive 63 percent credit for donations in 2010 and 70 percent for 2011 donations on their Kansas income tax.

Les Lacy, hospital administrator, said that the hospital has \$38,500 committed for 2010 and \$28,100 committed for 2011 for a total of \$66,950 to date. This, he said, is 22.3 percent of the total \$300,000.

Flooding and fire marshal

He found three deficiencies which included: the generator needs to be tested at a higher load capacity; two outlets in the kitchen needed ground fault circuit interrupter receptacles and there were four extension cords being used to help cleanup and drying be used; and, with the flood water, corridor which the marshal named as a deficiency.



Resolution to levy tax for capital outlay fund

Resolution to Levy Tax for Capital Outlay Fund

WHEREAS, the Board of Education of Unified School District No. 297, Cheyenne County, State of Kansas, is authorized by K.S.A. 72-8801, to make an annual tax levy at a mill rate not exceeding the statutorily-prescribed mill rate for a period of time not exceeding five years upon the taxable tangible property in the district for the purpose specified in said law; and

WHEREAS, the Board of Education has determined to exercise the authority vested in it by said law;

NOW, THEREFORE,

RESOLUTION

BE IT RESOLVED THAT the above-named school board shall be authorized to make an annual tax levy for a period not to exceed 5 years in an amount not to exceed 4 mills upon the taxable tangible property in the school district for the purpose of acquisition, construction, reconstruction, repair, remodeling, additions to, furnishing and equipping of buildings necessary for school district purposes, including housing and boarding pupils enrolled in an area vocational school operated under the board, architectural expenses incidental thereto, the acquisition of building sites, the undertake ing and maintenance of asbestos control projects, the acquisition of school buses and the acquisition of other equipment and for the purpose of paying a portion of the principal and interest on bonds issued by cities under the authority of K.S.A. 12-1774, and amendments thereto, for the financing of redevelopment projects upon property located within the school district. The tax levy authorized by this resolution may be made, unless a petition in opposition to the same, signed by not less than 10% of the qualified electors of the school district, is filed with the county election officer of the home county of the school district within 40 days after the last publication of this resolution. In the event a petition is filed, the county election officer shall submit the question of whether the tax levy shall be authorized to the electors in the school district at an election called for the purpose or at the next general election, as is specified by the board of education of the above school district.
