# **Group meets** to discuss nursing home

karen.k@nwkansas.com The Cheyenne County Commissioners met with members of city councils and other entities at the Monday meeting. The reason for this meeting was to discuss what could be done to hasten the opening of the Good Samaritan Village which was closed after a fire on Oct. 19. Consequently, residents were moved to surrounding towns and many of the staff were left without jobs.

Meeting with the commissioners were St. Francis and Bird City council members, Village advisory board members, Les Lacy, hospital administrator; Tom Keller, St. Francis Foundation member, and Sherry Carmichael, representing Bird City Century II along with several others

Mr. Keller was the primary spokesperson, noting that the group had decided to meet with the commissioners to brainstorm and form a task force to independently study the county's options. However, it was noted until more is known about what the Good Samaritan Society is going to do, it was impossible to make many plans. The fire investigation team will meet on Dec. 6 for interpretation of the prior investigations and, at that time, the Society may be able to better determine their course.

Mr. Keller said he had received an e-mail from Jeff Paulsen, Village administrator, telling that the Society had instructed Service Master, a cleaning business, to begin cleaning the kitchen, dining and lounge areas located on the east side of the facility where there was mostly smoke and water damage.

Service Master, he said, is authorized to clean out the east-west hallway in the burned area. The company will then cleanup the west ally right but it can't be done over- outstanding. wing. The beds, cabinets and wardrobes will be removed for salvage

of the Village advisory board, took the floor. He said he had talked to Mr. Fitzgerald before the meeting. We need to get rid of our assumptions, he said.

Mr. Fitzgerald had told him that he is willing to work with anyone of the entities (cities and county). We don't want to cut out the Society who has been working in the county for many years, Mr. Berens said. Some people have invested their lives with the Society.

Overall, it is important to keep the people in the community. Be active, be smart and temper with some patience.

We don't want to see Good Samaritan leave, said Dr. Mary Beth Miller. She added that she would like to see the committee to research the options. There is merit, she said, in owning the facility and having Good Samaritan manage it.

Scott Schultz, St. Francis mayor, suggested that there needed to be communication with Mr. Fitzgerald and the Society. He would like to see if their insurance would replace the burned area, then talk about bigger and better. In the southeast corner of the lot, he said, there is room for an assisted living facility. The bottom line for the present is to get the facility up and running, get the residents back and get the staff back to work.

Mr. Lacy suggested that the committee be a transparent group, bringing accurate information and options. For-profit groups, he said, are going to see the same demographics that Good Sam did. We need to work together with Good Sam for the best solutions to get the facility operating.

Roger Jensen, St. Francis City Councilman, cautioned that the group needed to be patient. This is an opportunity to do something renight.



The Society is coordinating with the state about regulations to reopen the west wing with food service from the kitchen and until this information is available, it is difficult to know how much time it will take. Some of the known requirements that must be in place are the sprinkler system, remote sensor monitoring and the call-light system.

A skeleton staff will remain based in the home health office from Nov. 28

Dale Patton, commissioner, said he would like to see the nursing home facility reopened as soon as possible with the consideration of improved service. In other words, get the facility up and running, then look at other options such as assisted living. He also thought that any potential ownership of the facility should be at the county level and there should be an action committee to work with the society and the governing board.

If the county had a committee in place which had studied the county's options, and the Society did turn over the facility to a county entity, time in reopening the facility could be shortened.

Throughout the discussion, there were negative as well as positive comments. Kevin Berens, member

Wallace County had just passed a bond to build a nursing home but it took two years. Did Cheyenne County have two years?

Mr. Berens said Mr. Fitzgerald was already exploring the options, looking into state regulations, serving meals.... there are just a whole lot of regulations. Then there is the Kansas Department of Health and Environment that will need to determine what can be used for the nursing home.

It will be three weeks until the investigation team meets and the Society has more facts, said Andy Beikman, commissioner. And, we have three weeks to gather information. We need to give Good Samaritan the first chance, then go from there.

Mr. Lacy said he would be going to Topeka and would make contacts in the Department of Health and Environment. He said he will gather as much information as possible.

As the discussion ended, it was agreed that each of the entities should appoint a person to work on the committee and report the name to Terry Miller, county clerk, before the next commissioners' meeting on Nov. 29.
