I have had the opportunity to see first-hand the care that is given by the staff of developmental services to the people they help. One of the young people who receives help at developmental services also has a Daddy that lives here at the Andbe Home. I see the staff bringing her to visit him two to three times a month. Isn't that wonderful to know that even if you are in a nursing home and your child is in a handicapped facility that someone cares enough for each one that the effort is made to get together. I don't think this would happen if these individuals were placed in a state hospital set-


