Norton wrestlers win J.R. Durham Invitational

Medaling eight wrestlers in the first nine weight classes from 103 to 151 pounds, Coach Bill Johnson's Norton Community High School wrestling team successfully defended last year's championship in the J.R. Durham Invitational Tournament on Saturday in the NCHS Memorial Gym in Norton.

The No. 1 state ranked (Class 3-2-1A) Blue Jays rolled up 161 points to outdistance Cozad, Nebraska, the No. 3 state-ranked team in Class B (equivalent of Class 5A in Kansas) in Nebraska. Cozad placed second with 136 points.

Scott City, the No. 10 ranked team in Class 4A, finished in third place with 101.5 points. Hoxie, who is ranked No. 2 in the state in Class 3-2-1A, finished in fourth place with 82.5 points, followed by Mill Valley, a Class 5A school, 80; Smith Center, No. 6 ranked in Class 3-2-1A, 77; Beloit, 77; TMP-Hays, 69; Atwood, 37; Russell, 31; Leoti, 26.5; Quinter,

Nine of the 14 wrestlers Norton entered in the tournament won medals by placing in the top four of their weight class. The Blue Jays had three champions, three runnersup and three third place finishers.


Winning gold medals for Norton were junior Clay Madden, 112; junior Lance Roe, 152 and senior Michael Sprigg, 275.

By vote of all the team coaches, Sprigg was named "Outstanding Wrestler" of the tournament.

Earning silver medals for Norton were sophomore Logan Keiswetter, 103; sophomore Nathan Broeckelman, 119 and sophomore Blake VanEaton, 145. Bronze medal winners from Norton were junior Jon Harding, 130; junior Jeremy Harding, 135 and junior Luke Pfannenstiel, 140.

"This was the toughest J.R. Durham Tournament that we've had for a long time," said Coach Johnson. "There were several brackets where some very good wrestlers did not even place.

"Cozad also had nine wrestlers in the finals so it was important that all of our wrestlers perform well for the sake of the team. We won three of six championship matches, with which I was not completely satisfied, but all three of our wrestlers going for third place won and that really helped in

In the consolation bracket, he pinned No. 4 seed Joe Beck, Mill Valley, in 1:58. In the consolation semi-finals, he was pinned in 2:38 by No. 3 seed Tim Erwin, Hoxie. Hillebrand's record is now 6-8.

In the semi-finals, he won an 8-4 decision over No. 1 seed Ben Mettlen, Scott City. In the championship finals, VanEaton wrestled No. 2 seed Tyler Sturgeon, Cozad, a competitive match. The first period ended with no score. VanEaton got an escape for the only point of the second period to take a 1-0 lead into the final period. Sturgeon scored three points in the third period to edge VanEaton 3-1 for the championship.

VanEaton is now 10-6 for the young season.
