We are writing as taxpayers and concerned citizens about the plan to tear off so many roofs this summer. When we read the newspaper article, we understood that it was a five-year proposal. Taking care of roofs is certainly necessary and a wise thing to do. You are to be commended for your foresight. However, we know the history of some of these roofs

Junior High Gym: In 1985 Roof-it Rite Inc. removed the roof, repaired the wood deck, and installed insulation and SWEPCO UNI-SHIELD single ply roofing. This is a modified bitumen roofing material. It was then coated with Aluminum Roof Coating made by Swepco. We have maintained and repaired this roof over the years. The only leaks, we are aware of, were at the scuppers at the NW, SE, and NE corners, due to ice and snow build-up. I repaired them. I believe this roof is sound and should last several more years with proper maintenance

South End of Eisenhower: The lower south roof, including the gym was roofed in 1986 under the supervision of Wayne Brungardt, architect, from the Stecklein Brungardt P.A. in Hays, Ks. Contour Products of Kansas City was the supplier of the tapered insulation. It was covered with SWEPCO SINGLE-PLAY UNI-SHIELD. It was coated with a black coating and the heat from it caused checks in the roof. The contract called for a ten-year guarantee. Some years later we coated it with aluminum roof coating. The roof has been repaired after hail storms. They do not appear to stand water. The Wrestling Building: It has the same tapered roof as the Eisenhower south end. The gym roof was torn down to the gypsum deck. A double lap base sheet was installed. Over that is two-inch contour foam insulation, 3/4 inch fiber board, and covered with Swepco single-ply uni-shield. This roof was also covered with black, which caused some checking. We objected to the black but had to follow the architect's plan. Later it was repaired and coated with aluminum roof coating. To my knowledge, the only leaks on it have been on the west side of the brick wall of the auditorium. This can be corrected by covering the wall with a membrane so there will not be a place to leak down into the building. This roof is solid and when the time comes to reroof a membrane could be installed without the expense of tearing off and installing all this again.

The consultant indicated that the roofs need to be replaced because they have failed These roofs have not failed. They have been maintained. With further proper maintenance, they should last a long time at a fraction of the cost of removing and installing new roofs. He also said he had not heard of SWEPCO. SWEPCO stands for Southwestern Petroleum Company located in Fort Worth, Texas. They sell roofing in other countries as well as the USA. They have been in business since 1933. They have a Dunn and Bradstreet AAA rating. They guarantee their roofs for 12 years and another eight if recoated at the
