# Fans enjoy motorcycle, quad races

Racing fans enjoyed watching professional and amateur motorcycle and all-terrain vehicle races by 155 riders on the fast half-mile track at Elmwood Park Speedway in Norton on Sunday evening.

Under sanction by the National Flat Track Racing Association and the American Motorcycle Association, the races kept fans on the edge of their seats as speeds on straightaways exceeded 100 miles per hour.

Local racers competed in the amateur and professional quads (ATV) races. Lucas Welch of Norton won his heat in the amateur quads and finished third in the feature to cement his lead for the season championship.

Jerry Jones, also of Norton, won his heat and was in second place in the feature with one lap left when he lost his brakes going into turn one and rolled. Jones suffered some sore muscles and officially finished seventh in the feature.

Jones also will finish second behind Welch for the season championship. It will be Jones' second straight runnerup for the championship.

Ron Rushton of Norton placed third in his heat and sixth in the feature.

Cory Puga of Norton was fourth in his heat and fifth in the feature. Hoss Jones of Norton raced in the pro quad division where he placed third in his heat and fourth in the feature.

The Honda Red Rider Rewards race was the feature event of the night. Davey Durelle, Fountain, Colo., lived up to his reputation as one of the top professional motorcycle riders in the nation by easily winning his heat in pro sport as well as the Honda feature and the \$2,000 prize money.

Durelle, who was pictured in Tuesday's Telegram, is also an eight-time winner of the Pike's Peak Hill Climb race.

Brigitta Meyer, Garland, Neb., suffered some broken bones when she crashed in the vintage 600 amateur motorcycle class and was admitted to the hospital in Kearney. Another driver was admitted and released from the Norton County Hospital following a race mishap.

Bill "Ironman" Snyder, Manhattan, remained undefeated this season in the vintage 375 cc and under class by easily winning the feature. He is a longtime motorcycle racer. At age 58, he has raced third:
