Coach Lively said that a big change in Kansas high school volleyball this season will be introduction of the libero position.

The player will wear a jersey of a contrasting color in order to be identified. She is a back row player who is there to pass and dig balls. The libero cannot serve, attack or set from in front of the attack line.

A libero player doesn't go through the substitution process; she simply runs onto the court during a dead ball and replaces a back row player. She may enter and exit the game unlimited times. Teams do not have to use a libero; it is a coaching strategy. If a team does use a libero, they will still be allowed 18 other substitutions.
