David Walter Buss, 52, Beaver City, died Tuesday at Phelps Memorial Hospital in Holdrege, from cancer.

Mr. Buss was born Nov. 9, 1953, at Gothenburg, Neb., to Walter and DeVona (Max) Buss.

He graduated from Cozad High School with the class of 1972. During high school, he placed three years in the Nebraska State Wrestling Tournament.

He worked several years at the New Holland Factory in Lexington, Neb.

On Nov. 21, 1981, he married Cheryl (Smith) Bates at Lexington. They moved to Beaver City in 1989.

Mr. Buss was a correctional officer at Norton Correctional Facility for the past 17 years. He was an avid Nebraska Cornhusker fan and loved high school sports.

He was preceded in death by his parents and a brother, Raymond Buss.

Survivors include his wife, Cheryl of the home; two sons, Jimmy and Carole Bates, Lincoln, Neb., and Ronald Buss, Kearney; two daughters, Shirley and Chris Longo, Cozad, and Jennifer Bates, Beaver City; two brothers, Robert Buss and Steve and Carolyn Buss, Cozad; two sisters, Carolyn Buss and Shirley and Glenn Schlichenmaier, Cozad; and four grandchildren.

"How to Age Gracefully" was the message Jan Volgamore, certified physical therapy assistant, gave to the members of Mid-Century General Federation of Women's Clubs on Nov. 10 at the home of Doris Winteroth with Leta Donovan serving as co-hostess.

Mrs. Volgamore's lesson included how to prevent falls at home. She said when adults over 60 fall, it can affect them, whether they are injured or not. If they are injured, it decreases their independence. If they are not injured, their confidence and their ability to live independently can be affected.

She suggested everyone should do a home assessment to identify hazards such as throw rugs, inadequate lighting, clutter on the floors, chairs that roll and lack of handrails on stairs. She suggested telephones should be easily accessible throughout the house.

She stressed the importance of exercise to increase flexibility and bone density.

Monday was a quiet day at the Dane Hansen Museum as the first blizzard of the season hit the area. Although everyone showed up for work, visitors didn't brave the elements. Streets were ice-packed, visibility poor, and harsh winds drove the snow.

Inside the gallery, the Chinese jade sat perched on its covered pedestals, safe from the elements. A dog carved in jade, lay curled up while an ox appeared to chew its cud. Even a horse and an elephant can be found among the ancient jade sculptures.

Dogs in China are seen as emblems of loyalty and good judges of character. A stray dog that adopts a family is said to be a har-

binger of approaching wealth.

The Chinese have found meaning behind many forms of life. The ox is gentle and peace loving but dangerous if goaded to anger. The elephant is wise and patient and possesses great strength.

Items in this collection from the Sackler Gallery date from 589 all the way to the 20th century. These are exceptional works of craftsmanship and the exhibit provides a rare opportunity to view such pieces of history and foreign works of art.

We hope you can visit the museum and see this display from the Smithsonian Institution entitled "Magic, Myths, and Minerals". It will show in the gallery through Jan. 29.
