Friday, June 30, is the last day to renew automobile, pickup, motorcycle and/or motorized bike tags for those whose last name begins with "H" and "I", or businesses whose name begins with "H" and "I". You must bring in or include proof of insurance for each vehicle, which includes the vehicle identification number, policy number and expiration date.


### Training offered Aug. 1-3 in Hays

Norton County farmers have until Tuesday, Aug. 1 to nominate candidates from the western onethird part of the county to run for the Norton County Farm Service Agency farmer elected committee.

The agency is looking for people who want to help out, get involved and work to help other folks in the business of agriculture in the community.

#### "We need more than a couple of local farmers to pitch in now and then," said Vesta Hobbs, Norton County Farm Service Agency director. "We need people who know the business of farming, are farming new or different crops, and those who can bring a different perspective to the USDA's (U.S. Department of Agriculture) work here in our area."

This year's election will be held Dec. 4. Candidates will only be taken from the western one-third part of Norton County.

## School leaving fees, meal prices the same

The Norton School District will not be raising fees for the 2006-07 school year.

Superintendent Greg Mann said he recommended that no changes be made to the district's fees, which include text book rental/enrollment fees, meal prices and mileage reimbursement.

He said the district raised the price of text book rentals in June of 2002 and raised the meal prices last year. Meals went up 10 cents per lunch, 5 cents per breakfast, and 5 cents for additional milk.

Lunch prices for the 2006-07 year will be \$1.40 for kindergarten through third grade students, \$1.50 for fourth through sixth grade students, \$1.70 for seventh through twelfth grade students, and \$2.45 for adults. Breakfast costs will be 80 cents for kindergarten through sixth grade stu- kept it low to encourage staff to take

dents, 95 cents for seventh through twelfth grade students, and \$1.40 for adults. Additional milk will be 20 cents per each half pint carton.

Text book rental/enrollment fees will be \$8 for early childhood development and kindergarten students, \$14 for first through sixth grade students, \$20 for seventh and eighth grade students, and \$25 for ninth through twelfth grade students.

Mr. Mann said for mileage reimbursement, he recommended that parents who drive their special education students to school receive 44 cents per mile, which is state approved rate. As for staff members, he said they have paid 26 cents per mile for a while. The amount is well below that which is paid by most government agencies, he said, but the district has

school vehicles rather than their own.

The board approved the fees for the 2006-07 school year and also approved a motion to once again take part in the Federal School Nutrition program.

In other business, the board:

 Adopted the 2006-07 student-parent handbooks for the high school, junior high and grade school.

 Approved Wes Georgeson, Amy Richard, Lacey Roe and Blake VanEaton as the student members of the Stull Gym Appreciation Plaque Committee and directed Mr. Mann to contact any of the six adults recommended until three have agreed to serve on the committee.

• Accepted a bid of \$104,435 from Boxler Insurance of Norton for the district's property, vehicle, workmen's
