

## Farmers can get loans for storm losses

Rawlins and Phillips counties who duction loss from the disaster. suffered crop or livestock losses from the Dec. 28-31 winter storm may now apply for Farm Service Agency emergency loans.

Applications for assistance will be accepted by the agency until Sept. 24.

Loans covering physical and/or production losses may be made at a 3.75 percent interest rate, and are scheduled for repayment as rapidly as feasible, consistent with the applicant's reasonable ability to pay, said Farm Loan Manager

The loans covering physical losses may be used to replace installations, equipment, livestock or buildings (including homes) that were lost through this disas-Production loss loans may be used to buy feed, seed, fertilizer, livestock, or to make payments on real estate and chattel debts. The money can also be used for other essential operating and living expenses, said Vogt. To be eligible for an emergency disaster loan, an applicant must be operating a family size farm or ranch, must be unable to get credit elsewhere, and must have suffered
