The Norton boys scored 78 points to win the championship. Phillipsburg tallied 72 for second and Concordia placed third with 69. Fourth place went to Chapman with 65, followed by Abilene, 59; Minneapolis, 58; Beloit, 54.50; Thomas More Prep of Hays, 42.5; Russell, 42; Larned, 17.

Concordia won the girls championship with 151 points. Beloit was second with 93 and Norton was third with 92. Thomas More Prep-Marian placed fourth with 63, followed by Abilene, 61; Phillipsburg, 34; Larned, 23; Minneapolis, 21; Russell, 7; Chapman,

"Our girls finished the meet by capturing third place, posting four new season bests and one personal record. They continue to steadily improve as the season progresses, a result of their continued hard work and great effort.

"Our boys team edged Phillipsburg to once again win the meet championship team race. As a group, they took one seasonal best and six personal records from the meet. They, too, continue to show steady improvement from week to week.






