## Bonnie V. Wurm

July 11, 1930 - Aug. 5, 2007

Bonnie Valeria Wurm, 77, a longtime resident of rural Oberlin, died Aug. 5, at the Decatur County Hospital as the result of anaplastic thyroid cancer.

She was born July 11, 1930, the eldest of three children of Bert and Nellie (DeYoung) VanDeWege, at the family farm home near Prairie View. She attended country school in the Prairie View area and graduated from Almena High School. She attended Fort Hays State University, graduating with a Bachelor of Science degree in elementary education. While attending college, she taught elementary classes in Almena and Long Island. After graduating, she started teaching in Colby. She retired from her career of teaching from Golden Plains School District, Selden/Rexford.

She married Arlo Wurm on Dec. 27, 1961, at the Reformed Church in Prairie View. They made their home on a farm southwest of Oberlin, where they reared their five children. She was a member of St. John's Lutheran Church and Calico Gals Club. She was also a 4-H co-leader for Sappa Valley 4-H Club. She was a recipient of a kidney after her retirement.

She was preceded in death by her parents; her in-laws, John and Lydia (Unger) Wurm; two brothers-in-law, Jimmy McKay and Raymond Wurm, and a niece, Jillian Epard.

Survivors include her husband, Arlo, rural Oberlin; four sons, Kevin and Kayla Wurm, Dresden, Keane Wurm, Hays, Stanton and Rochelle Wurm, Lebo and Shane and Christy Wurm, St. Francis; a daughter Shawna Lea and Mike Karl, Brighton, Colo.; a brother, Harlan VanDeWege, Prairie View; a sister, Neva and Rich Epard, Colby; two sisters-in-law, Phyllis (Wurm) McKay, Jenks, Okla. and Mary Wurm, Loveland, Colo.; and nine grandchildren;
