In other items:

- Laryl Rous suggested naming the football field in honor of Coach Chuck Fessenden. Superintendent George Griffith will look into options and seek feedback.
- A motion was approved to count horticulture and animal sci-

ence as one half credit of science each, with the superintendent's supervision of curriculum and program standards.

- The superintendent distributed copies of recommended revisions for the 7-12 handbook for board members to review. Teachers and student council members had input into the revisions. This topic will be addressed at the next meeting, allowing the board

ample time to digest the information provided.

- The board moved to not approve acceptance of the republished budget.
- Superintendent Griffith recommended that junior varsity games be held the same day as varsity games in order to save on fuel expenses.
- PreK-8 Principal Chris Robertson told the board the sound system at the Long Island school

is not sufficient for use at the football field. She also told the board the state fire marshal has recommended that the side balconies in the Long Island School not be used until they have been inspected by a structural engineer.

All board members were present for the meeting — Gale Hays, president; Doyle Baird, vice president; and Glenn Brands, Blaine Marble, Christopher Rogers, Chris Schemper and Alan Woodside.


