

ORDINANCE NO. 1576

Published in The Norton Telegram on Tuesday, June 24, 2008

AN ORDINANCE AMENDING CHAPTER 9, **ARTICLE 1 OF THE NORTON CITY CODE RELATING TO MUNICIPAL COURT COSTS**

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS:

Section 1: Section 9-105 of the Code of the City of Norton, Kansas, is hereby amended to read as follows:

9-105. Court Cost Fee. In all cases filed in the Municipal Court of Norton. Kansas, where there is a finding of guilty or a plea of guilty, a plea of no contest, forfeiture of a bond, or a diversion, there shall be assessed a cost as provided below. The costs shall be for the administration of justice in the Municipal Court and for the implementation of the Judicial Branch Education Fund, the law Enforcement Training Reimbursement Fund, the Law Enforcement Center Funds and the State Trauma Fund. Said funds shall be remitted to the State Treasurer or deposited in the State Treasury to the credit of the appropriate funds.

The court	costs	shall	be	as	follows

a.	Infractions and moving violations	\$75.00
b.	Misdemeanors, criminal and public offenses	\$75.00
c.	Parking violations	\$ -0-
d	Marrant foo	¢05 00

For the purposes of determining the amount to be assessed, if more than one complaint is filed against one individual arising out of the same incident, all such complaints shall be considered as one case. In addition to the court costs and penalties, a person who fails to comply with a traffic citation, except for illegal parking, standing or stopping, shall be mailed a notice that if such person does not appear in municipal court or pay all fines, court costs and penalties within thirty (30) days from the date of mailing notice, the division of vehicles will be notified to suspend

the person's driving privileges. The municipal court shall charge a fee of \$5.00 for mailing such notice, which shall be assessed as costs. Section 2. That any ordinances in conflict herewith are hereby amended.

Section 3. This ordinance becomes effective upon publication in the official city newspaper


