"We put together enough food for Christmas dinner, age-appropriate toys, and maybe some coats, and mittens and sometimes even some blankets," said Tom Baumann, chairman of the Christmas Basket Project. "In a basket there is a ham, milk, bread, butter, potatoes, canned vegetables and fresh fruit."

This year, the club delivered 95 baskets to families in need in every town in Norton County. About 15 people gathered to put the baskets together.

"That's about the average number of baskets," said Mr. Baumann. "These past few years, we've been running into the nineties."

The Lions Club receives the items for the baskets from area


