Iayvee wrestlers do well in tourney

The Norton Community High School junior varsity wrestlers competed on Saturday in the annual varsity Arapahoe Warrior Invitational tournament in Arapahoe, Neb. and did very well representing the "Fighting Blue Jays".

Five of the six Norton wrestlers placed in the tournament. Taylor Gordon, 103; Justin Waggoner, 125 and Trey Millan, 135, each placed third in their weight divisions and Andy Nickell, 112 and Casey Robison, 171, each placed fourth.

Also competing for the Blue Jays was Cayleb Campbell, 160. Elwood won the team championship with 148 points, followed by ElmCreek, 139; Wauneta/Palisade, 111; Arapahoe, 82; SEM, 78; Fleming, Colo., 60; Eustis-Farnam, 48.5; Norton JV, 41; Axtell, 29; Unified JV, 7; Cozad JV, 0.

"In our last competition in Nebraska for the year, our second team continued to do well and improve," said Norton assistant wrestling coach Shane Miller.

"The Arapahoe Invitational is more competitive than some of the others we've competed in with our junior varsity. Even though we didn't have any finalists, there were some good semi-final battles. Most of our opponents we face have had more mat time than our second team and, in some close matches, it showed.

"I was very pleased with how our team competed."

Trey Millan was chosen "Junior Varsity Wrestler of the Week" for his fine performance in the tournament.

RESOLUTION NO. 2009-05

A RESOLUTION INDICATING THE INTENT OF THE GOVERNING BODY OF NORTON COUNTY, KANSAS, TO ENTER INTO A LEASE-PURCHASE AGREE MENT IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED FOUR HUNDRED FIFTY THOUSAND DOLLARS (\$450,000) FOR THE PURPOSE OF PROVIDING FUNDS TO ACQUIRE, PURCHASE AND EQUIP AN EMERGENCY MEDICAL SERVICES BUILDINGS; AND AUTHORIZING THE OFFERING FOR SALE OF CERTIFICATES OF PARTICIPATION IN SUCH LEASE PURCHASE AGREEMENT.

WHEREAS, under the Constitution and statutes of the State of Kansas, particularly K.S.A. 10-1116b and 10-1116c (the "Act"), Norton County, Kansas (the "County") is empowered to enter into leases and lease-purchase agreements for the lease and acquisition of real and personal property upon such terms and conditions as deemed necessary by the governing body of the County; and

WHEREAS, the governing body of the County finds it necessary and desirable to acquire, purchase and equip an emergency medical services building located in the County (the "Project") to further its governmental and public purposes; and

WHEREAS, the County has immediate need to finance the acquisition of the Project in order to further its governmental and public purposes, but does not have moneys currently allocable to pay the costs of the Project; and

WHEREAS, in order to provide for the financing of the Project, the governing body of the County finds it necessary and desirable to enter into a Lease Purchase Agreement (the "Lease") and to offer and sell certificates of participation in the Lease (the "Certificates"), which evidence proportionate interests in and rights to receive payments under the Lease, all pursuant to the authority provided by Kansas Law, including the Act; an

WHEREAS, the County has selected DeWaay Financial Network, LLC, Wichita, Kansas (the "Underwriter") as underwriter of the Certificates representing the interest in the Lease; and

WHEREAS, the Lease involves the acquisition of land and buildings and is for a term exceeding the current fiscal year, and provides for rental payments which in the aggregate exceed \$100,000.

NOW THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF PARSONS KANSAS

SECTION 1. The County intends and is hereby authorized to finance the Project in an amount which will not exceed the cost of \$450,000 in aggregate principal amount, subject in all respects to the negotiation of satisfactory lease-purchase arrangements for the Project. The total of all payments to be made pursuant to the Lease is estimated to be \$652,000 for the purpose of acquiring the Project.

SECTION 2. The Underwriter is authorized and directed to prepare and distribute the Preliminary Official Statement, in cooperation with Triplett, Woolf & Garretson, LLC, as Special Counsel. The Chairman and County Clerk are authorized to execute the Preliminary Official Statement. The Preliminary Official Statement is authorized to be distributed (in its entirety) to prospective purchasers.

SECTION 3. Before the County enters into the Lease and before any Certificates are issued, this Resolution shall be published once a week for two (2) consecutive weeks in The Norton Telegram, a newspaper of general circulation within Norton County, Kansas and if within thirty (30) days after last date of publication of this Resolution, a petition in opposition to this Resolution signed by not less than 5% of the qualified voters of the County is filed with the County Election Officer, the Board of County Commissioners shall submit the question to the voters at an election called for that purpose or at the next general election before entering into the Lease or issuing the Certificates. If no sufficient protest is filed with the County Election Officer within the period of time hereinbefore stated, then the Commission shall be authorized to enter into the Lease and proceed to issue the Certificates to pay the costs of the Project.

SECTION 4. This Resolution shall become effective upon its approval and passage by a majority vote of the governing body of Norton County, Kansas.
