For cats, the distemper vaccine will cost \$16, and the feline leukemia vaccine will cost \$19.

# Fire renders Norton home useless

The Norton City Fire Department was called to a house fire early Tuesday afternoon at 509 north Archer.

The owner of the house is Charles Blair, Castle Rock, Colo. The house was being rented to Virgil and Donna Wilcox, said Kirk Nuzum, assistant

fire chief, who also said the house was a total loss.

Within half an hour after firefighters arrived, part of the ceiling inside the house fell. The force of the ceiling falling on the floor broke out several windows and

raised one side of the roof. There were paged for additional manpower. two firefighters inside the house when the "There was no one inside when the fire ceiling fell, but they were uninjured.

"We stayed out of the house after the ceiling fell," said Mr. Nuzum. "We did knock the chimney down for safety reasons. There were no natural gas or electric issues during the fire."

#### Cheerleaders a question mark at high school

The Norton School Board may decide suspend cheerleading at the high school for the 2009-2010 school year. Superintendent Greg Mann said there has been a decline in interest in cheerleading and finding a sponsor for the program has been difficult.

"In the past, the high school cheerleading squad consisted of 12 cheerleaders," said Mr. Mann. "We haven't had that for the past two years and last spring we had only 12 try out and the year before we had 13. This year, the squad started out with 10 cheerleaders, and we finished the year

Mr. Mann declined to elaborate on why all six had left the squad, but did say that one member of the squad had moved away.

Mr. Mann said he would like the board to consider if the cheerleading program is accomplishing what it's intended to accomplish — which is a positive educational leadership experience for all people involved — and asked the board to give serious thought to not having cheerleading next year.

Board member Craig Renner suggested waiting to see what the interest level is for the next school year before making a decision. Mr. Mann said high school principal Rudy Perez can look into the level of interest and report back at the next school board meeting on April 13.

As of Thursday morning, six students had signed up to try out for cheerleading in the 2009-2010 school year.

# Board receives update on survey, dairy recruitment

Updates on the business survey and at the next meeting. the dairy recruitment trip were items for the Norton City County Economic Development board meeting Tuesday

Janis Monier presented the first of a three part presentation on the business survey results that she had. She said there are 178 active businesses in Norton County that were contacted. She has over 300 pages of notes that she will be condensing. Some of the information has been given to the economic development office for compiling into a business directory that can be handed out. Director Diane Becker and office assistant Verla Grysch are working on getting all the businesses into categories. They hope to have a presentation

Ms. Monier said some of the issues for businesses are the economy, affordable child care and the one mentioned most often is the condition of the streets, sidewalks, curbs and gutters in all of the cities. They would like to see more young people get involved in local government and get more information out to the businesses. They also said that the existing businesses need to be taken care of and the businesses on Highway 36 don't want to be forgotten. The business owners also felt that there needs to be more attention paid to the lake and promoting more activities there. Ms. Monier will present more information at the next meeting.
