# Commissioners approve purchase

The Norton County Sheriff's office will be getting a new vehicle soon, thanks to action taken by the Norton County Commission at its March 9 meeting.

The commissioners approved the purchase of a 2009 Dodge Charger for \$22,452.60 from Odessa Ford in Kansas City. There were two other bids, a 2009 Chevy Impala for \$21,748 from Money Chevrolet, Hill City and a 2009 Ford Crown Victoria from Tubbs and Sons, Colby for \$22,928.64.

Though it was not the lowest bid, Sheriff Troy Thomson said he felt the Charger would be the best purchase because the Impala doesn't hold up well to all the driving and it has a low ground clearance.
