PUBLIC NOTICE ORDINANCE NO. 1583

Published in The Norton Telegram on Tuesday, April 7, 2009. ORDINANCE NO. 1583 AN ORDINANCE ALLOWING FOR THE RECOVERY OF COSTS OF COLLECTION AS TO DELINQUENT ACCOUNTS OWED TO THE CITY OF NORTON, KANSAS, AND ADDING A NEW ARTICLE 8 TO CHAPTER ONE OF THE CODE OF THE CITY OF NORTON. NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS Section 1: The Code of the City of Norton is hereby amended by adding Chapter 1, Article 801, which reads as follows: 1-801. COSTS OF COLLECTION. That from and after the effective date of this ordinance, any and all liquidated sums due and owing to the City of Norton, Kansas, which have accrued through contract, subrogation, tort, operation of law, court order, or any other legal theory regardless of whether there is an outstanding judgment for that sum, including special assessments, fines restitution, and penalties, shall entitle the City of Norton to reimbursement of the costs of collection from the debtor/defendant or customer. That the cost of collection shall be assessed as an additional cost. That the cost of collection for the State debt set-off program shall be the amount charged by the Director of Accounts and Reports of the Department of Administration for collection. The cost of collection when contracts are entered into for collections services shall not exceed 33% of the amount collected. That the cost of collection shall include debt set-off fees, court costs, attorney's fees and collection agency fees. That the cost of collection shall be applied prior to referral for collection, for all known fees. Section 2: This ordinance shall be effective upon publication in the official city newspaper.
