We learned this week that the House Appropriations Committee is proposing DEEP cuts into the developmental disabilities services system. A vote on a bill is scheduled for this week in the Kansas House of Representatives that if passed would have a devastating effect on Developmental Services and people with developmental disabilities throughout northwest Kansas. This budget bill would cut more than \$20 million from HCBS DD Waiver, which was already services for Kansans with developmental critically underfunded. This cut will redisabilities. This represents an almost 10 percent cut in funding for Kansas' most

• An almost 50 percent cut in Family Support Grants (\$6.75 million) which are used to provide vitally needed help to families who care for a loved one with a developmental disability. Loss of these dollars will devastate Kansas families who already struggle with the extensive, round-the-clock needs of someone who has a significant disability.

• A cut of more than \$8 million in the economy was doing well or not.

Total Proposed Cuts for DSNWK area: \$994.000

DSNWK is heavily reliant on funding from the State, via the Home and Community-Based Developmental Disabilities Waiver (HCBS DD Waiver). DSNWK has suffered from chronic underfunding from the State of Kansas for more than 15 years, regardless of whether the State's

Since 1993, increases in reimbursement rates for the HCBS DD Waiver sult in an even larger waiting list for help have increased only 29 percent. During (waiting lists already number more than that same time, inflation increased more
