AN ORDINANCE AMENDING SECTION 15-204 OF THE NORTON CITY CODE RELATING TO **UTILITY SERVICE WATER TAP FEES** 

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS:

Section 1: Section 15-204 of the Code of the City of Norton is hereby amended to read as follows:

> a. That the City will provide the following service lines. That there is hereby established a single one time tap fee for water services within

15-204. TAP FEE.

the corporate limits of the city: 1. 3/4" water line service - \$450

2. 1" water line service - \$500

3. 2" water line service - \$1000 4. Relocation of service meter or upgrade to 1" - \$175.00

The owner-applicant shall further be responsible for the cost of installation and pipe in addition to the above established tap fees with respect to any water service to be installed more than 100 feet from existing water mains, and the owner-applicant for such water service shall pay 1/2 of the cost of the water meter and installation with respect to water service on lines over 1 inch diameter.

b. The same nonrecurring single water tap fees shall be applicable as stated in subsection (a) with respect to water service to locations outside the corporate limits of the city and that in addition thereto the owner-applicant shall pay the city the cost of connecting to existing water mains.

Section 2: This ordinance shall be effective upon publication in the official city newspaper
