An ordinance setting an election date on the question of adoption of Charter Ordinance #4 concerning the holding of appointive offices by non-residents

Be it ordained by the Governing Body of the City of Norcatur, Kansas: **SECTION 1.** Charter Ordinance #4 was adopted by the Norcatur City Council on July 20, 2009 and the required publications were made of same. **SECTION 2.** On September 16, 2009 a petition was filed with the city requesting an election on the issue of the adoption of said Charter Ordinance. Said petition has been validated by the county election officer and an election is required to be held pursuant to Article 12, Section 5 of the Kansas Constitution. **SECTION 3.** The election on the question of adoption of said Charter Ordinance is hereby scheduled for Dec. 15th, 2009. **SECTION 4.** This ordinance shall be published once each week for three consecutive weeks in the official city newspaper.
