AN ORDINANCE RESTRICTING VEHICULAR PARKING, ON THE NORTH SIDE OF EAST WARSAW STREET IN NORTON, KANSAS, STARTING AT THE TERMINUS OF NORTH NORTON STREET AND EAST WARSAW STREET THENCE EAST ONE HUNDRED AND NINE FEET.
NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS, A MUNICIPAL CORPORATION, AS FOLLOWS:
Section 1: That from and after the effective date of this ordinance, it shall be unlawful to park any motor vehicle on the north side of East Warsaw Street, starting at the terminus of North Norton Street and East Warsaw Street, thence East One Hundred and Nine Feet.
Section 2: Violation of this ordinance shall be punishable in accordance with the provisions of the Standard Traffic Ordinance of the City of Norton, Kansas.
Section 3: This ordinance shall take effect from and after the date of its publication in the official city newspaper, and the signs being duly placed.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS, A MUNICIPAL CORPORATION, AS FOLLOWS:
