# Plans for business incubator continue

Work on the Moffet building is continuing with plans being discussed to move the Norton Area Chamber of Commerce and Norton City/County Economic Development into the building when construction is completed. The move will allow a business incubator to be put in the building the chamber currently occupies.

An incubator will help entrepreneurs start a business by working closely with economic development to access local as well as regional resources.

"We'll mentor them through the process to help make their businesses successful," said Diane Stiles, Norton City/County Economic Development Director.

Stiles said she would be developing guidelines for the incubator. A business plan will be required of any

startup interested building.

She said other cities offer incubators like the one in Kansas City which offers a technology startup incubator.

Stiles said Norton's incubator will focus on the retail or service industries.

The chamber and economic development have not signed a formal agreement yet. Stiles said she proposed the move in Anoust

# *Court hears appeals*

kbottrell@nwkansas.com Before an audience of attorneys, students and community members, three judges from the Kansas Court of Appeals sat at the Thomas County Courthouse last week to hear cases from western Kansas.

Judges Stephen Hill, Nancy Caplinger and Steve Leben convened on Tuesday and Wednesday afternoon to hear 15 cases involving everything from driving

under the influence to adoption.

The appeals court hears cases that have been decided in a lower court and one of the parties involved is seeking to overturn that ruling. Hill said the judges are supplied with written briefings on the cases and a research memo on each from the court's research staff. The attorneys for each side typically have 15 minutes to present their oral arguments, and the appellant, the party seeking a verdict (Appeals - Continued on Page 5)

# 4-Hers honored at achievement night

The event is open to the public and will include dinner before the awards ceremony. Dinner will start at 5 p.m. The Norton Area Chamber of Commerce will co-sponsor the main dish and 4-H families will provide side dishes. The ceremony will begin at 6 p.m.

A variety of 4-Hers will be honored, said Keith VanSkike, Twin Creeks Extension District Agent. Awards will be given

for achievement, yearly recognition pins, club promotion, judging, project completion and other awards.

"This is the awards culmination for the year," he said.

The Friend of 4-H award will also be presented to a community member who has contributed their time and leadership to 4-H. George Jones started the award many years ago. The award is cosponsored by the Norton Area Chamber of Commerce.
