That there shall be no fewer than three copies of the National Electrical Code, 2008 Edition, kept on file in the City Clerk's Office and kept available for inspection by the public at all reasonable hours. That at least one copy of the standard code shall be marked "Official Copy as incorporated by Ordinance No. 1596." All sections or portions of the filed copies of the standard code shall be clearly marked to show deletions from the standard code.

Section 2: That any ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3: That any section or phrase of this ordinance is for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance

Section 4: That nothing in this ordinance or in the Electrical Code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 6: This ordinance becomes effective upon publication in the official city

AN ORDINANCE AMENDING CHAPTER IV, SECTION ONE OF THE NORTON CITY CODE RELATING TO BUILDING CODES AND ADOPTING THE INTERNATIONAL BUILDING CODE WITHIN THE CITY OF NORTON, KANSAS

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS:

 $\textbf{Section 1:} \ \ \textbf{Section 4-101} \ \ \textbf{of the Code of the City of Norton is hereby amended to}$ read as follows:

Section 4-101 BUILDING CODES INCORPORATED. That a certain standard code known as the International Building Code, 2006 Edition, published by the International Code Council is hereby incorporated by referenced and made a part of this article. That there shall be no fewer than three copies of the International Building Code, 2006 Edition, kept on file in the City Clerk's Office and kept available for inspection by the public at all reasonable hours. That at least one copy of the standard code shall be marked "Official Copy as incorporated by Ordinance No. 1594." All sections or portions of the filed copies of the standard code shall be clearly marked to show deletions from the standard code.

That the following sections are hereby revised:

Section 101.1. Insert: City of Norton, Kansas. Section 1612.3 Insert: City of Norton, Kansas.

Section 1612.3. Insert: July 16th, 1987. Section 3410.2. Insert: The adoption of this code.

Section 2: Section 4-107 of the Code of the City of Norton is hereby amended to read as follows:

Section 4-107 PERMIT REQUIRED.

a. Before beginning any building, construction, or repair work, a builder or building contractor shall apply to the building inspector and obtain a permit to do such work. All such work shall meet the building code requirements. An owner must also apply for a permit if the owner does the work but an owner is not subject to a late application fee.

b. All applications for permits shall be made on suitable forms provided by the city. c. The application shall be accompanied by a \$5 permit fee.

d. A builder or building contractor who does not apply for a permit prior to beginning the construction may be charged a late application fee. That said late fee may be assessed at \$5.00 per day for any day the permit was

required and not applied for or obtained. e. Section 105.2 of the International Building Code, as in effect, shall be amended to include: "Exterior surface work of a structure, including the walls and roof, so long as the structural framework of the building is not repaired, modified or enlarged."

Section 3: That any ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4: That any section or phrase of this ordinance is for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 5: That nothing in this ordinance or in the Building Code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 6: This ordinance becomes effective upon publication in the official city

certain standard code known as the International Property Maintenance Code, 2006 Edition, published by the International Code Council is hereby incorporated by referenced and made a part of this article. That there shall be no fewer than three copies of the International Property Maintenance Code, 2006 Edition, kept on file in the City Clerk's Office and kept available for inspection by the public at all reasonable hours. That at least one copy of the standard code shall be marked "Official Copy as incorporated by ordinance No. 1597." All sections or portions of the filed copies of the standard code shall be clearly marked to show deletions from the standard code.

The following sections are hereby revised

Section 101.1 Insert: City of Norton, Kansas.

Section 102.3 Insert: National Electrical Code in place of ICC Electrical Code.

Section 103.5 Insert: That the City shall adopt a schedule of fees by Resolution which may be amended from time to time.

Section 4: A New Section 4-502 of the Code of the City of Norton shall read as follows:

4-502 DEFINITIONS. Where the term "Code Official" is referred to in the International Property Maintenance Code, such term shall include the Building Inspector or Code Enforcement Officer for the City.

Section 5: A New Section 4-503 of the Code of the City of Norton shall read as

4-503 BOARD OF APPEALS. Where the term "Board of Appeals" is used in the International Property Maintenance Code, such Board shall be hereby established consisting of the members of the governing body. The board shall consider appeals in accordance with those procedures outlined in Section 111 of the international Property Maintenance Code.

Section 6: A New Section 4-504 of the Code of the City of Norton shall read as follows:

4-504 PENALTY. The violation of any provision of this article shall be deemed to be a misdemeanor; and any person, firm, association, partnership, or corporation convicted thereof shall be punished by a fine of not less than \$100 or greater than \$500 per offense; and the city shall further have the authority to maintain suits or actions in any court of competent jurisdiction for the purpose of enforcing any provisions of this article and to seek civil penalties in the amount of not less than \$100 or greater than \$500 per offense and to abate nuisances maintained in violation thereof, and, in addition to other remedies, institute injunction, mandamus, or other appropriate action or proceeding to prevent such unlawful erection, construction, reconstruction, alteration, conversion, maintenance, or use, or to correct or abate such violation, or to prevent the occupancy of the building, structure or land. Each day a violation of this article shall continue shall constitute a separate offense.

be marked "Official Copy as incorporated by Ordinance No. 1598." All sections or portions of the filed copies of the standard code shall be clearly marked to show deletions from the standard code. That the following sections are hereby revised:

Section 101.1 Insert: City of Norton, Kansas Section 109.3. Insert: Misdemeanor, \$100.00, 30 days. Section 111.4 Insert: \$100.00, \$1000.00 Section 2: Section 7-303 of the Code of the City of Norton is hereby amended to

Provided, however, that liquefied petroleum gas may be stored in containers not exceeding 1,000 gallons in capacity in the Light Industrial District when installed in full compliance with the State Fire Marshal's Regulations, and not within 50 feet of a highway.
