## Patrol watching for impaired drivers

Super Bowl Sunday is one of America's biggest and most entertaining sporting events, as friends and families gather to socialize and watch the big game. Unfortunately, it also has become one of the nation's most dangerous days to drive, due to impaired driving.

According to research by the National Highway Traffic Safety Administration, in 2008, fatalities in alcohol-impaired-driving crashes accounted for 32 percent of all motor vehicle traffic fatalities.

On Super Bowl Sunday (Feb. 3 to 5:59 a.m. Feb. 4), 49 percent of the fatalities occurred in crashes tics, and they will be vigilant before, during and after the game," Kansas Secretary of Transportation Deb Miller said.

"Those who try to beat the system risk stiff fines and mandatory imprisonment.

"And if you are involved in a crash that takes a life, even if you survive, your life will be changed forever.'
