

# Northern Valley loses to Alma, Neb

The Northern Valley Huskies boys basketball team lost to Alma 60-34 on Tuesday.

The first quarter of the game was off to a slow start for Northern Valley with the Huskies only scoring two points by Dusty Eagleburger. The Alma Cardinals made a whopping 16 points during the quarter, ending the quarter 16-2.

The second quarter got better for the Huskies with Colton Lowry making one shot from beyond the arc, a two point shot and one of two free throws. Austin Herman also made two. The Cards scored only 4 points but they still led 20-10 at halftime.

Third quarter scoring was very close. Eagleburger sank a three pointer, a two pointer and both of his free throws. Lowry made one from outside the arc, Herman had a two point basket and Tyler Montgomery hit one of his two free throws. Even though the Huskies scored 13 points, the Cards added 14 more to their total to lead 34-23.

Herman led Husky scoring in the fourth quarter with a three point basket, three two pointers and one free throw. Michael Callaway helped by hitting one of two free throws. Despite all their efforts, there was no chance of the Huskies taking the win, especially with the Alma team scoring 26 points in this final quarter.

Coach Chuck Fessenden said, "We had a poor first quarter offensively and put ourselves in a hole. We were able to cut into the lead several times but Alma responded well and ran it back up over 10 points."

The leading scorer for the Huskies was Austin Herman with 14 total points, followed by Eagleburger and Lowry, 9 each and Montgomery and Callaway, 1 each.

The next Northern Valley boys basketball game will be tonight at Kensington against Thunder Ridge.

# Huskies beaten by Thunder Ridge

Last Friday the Northern Valley Huskies boys basketball team took on Thunder Ridge at home, losing 60-39.

The first quarter was hard fought with Dusty Eagleburger scoring six points plus one free throw. Bryant Tharman added another basket and two free throws and Austin Herman sank one more two pointer.

Thunder Ridge seemed to be dead on in their shooting. The quarter ended with the Huskies trailing 21-13.

In the second quarter, the Huskies led in scoring when Herman hit a three point shot as well as a two pointer. Eagleburger had four points in the quarter with Zach Vincent and Tyler Montgomery each making two more. Thunder Ridge's inability to make their free throws hurt them in this quarter. The half time score still had Thunder Ridge leading 30-26.

In the second half, the Huskies lost some steam. Herman and Eagleburger each scored two and that was all for the quarter.

Thunder Ridge stayed on their roll, making 19 more points. The third quarter ending score was 49-30.

The Husky scoring was better in the last quarter but not enough to take the lead. Jeremy Brown hit a two point shot and one free throw. Herman, Eagleburger and Brandon Towery each added two more to the tally.

The nine points scored by the Huskies just wasn't enough to get the win over Thunder Ridge's eleven points earned in the quarter.

Coach Chuck Fessenden said, "We played a good solid first half. Then in the third quarter we started taking some bad shots and gave up offensive rebounds and let Thunder Ridge get away from us."

High scorer for the Huskies was Eagleburger with 15 total points, followed by Herman, 11; Tharman, 4; Brown, 3; Vincent, Montgomery and Towery, 2 each.

# Jayvee wrestlers place sixth

Five junior varsity members of the Norton Community High School wrestling team competed in the annual varsity Arapahoe Warrior Invitational Tournament on Saturday in Arapahoe and performed very well, placing sixth as a team.

Elwood won the championship with 121 points, followed by SEM, 115.5; Fleming, Colo., 101.50; Arapahoe, 100; WP-HC, 90; Norton JV 68.5; Eustis-Farnam, 47.50; Atwood, 43; Elm Creek, 37; Axtell, 27; Unified, 14.

Eli Bozarth won the 145 pound championship for Norton. Taylor Gordon, 103, and Rylee Stanley, 152, each placed runner-up and Cody Ellis, 130, finished in third place. Jared Bohl wrestled at 140 pounds and finished sixth.

"Even though some brackets were small, the quality of the competition was good," said Norton assistant wrestling coach Shane Miller. "The middle weights proved to be some of the best competition our junior varsity

wrestlers have seen this season. "Since most weight classes had fewer than eight wrestlers, it was decided to make this a round robin tournament format with the winners of each pool facing each other in the final round."

Eli Bozarth won his championship by pinning Lance Taylor, UJV, in 1:22; winning an 11-3 decision over Calvin Frerichs, SEM; pinning Mitch Kubert, Elwood, in 2:47 and winning an 11-7 decision over Patrick Gardner, Arapahoe.

"Eli put together his best tournament of the year," said coach Miller. "He went 4-0 for the day with two pins, one major decision and an exciting 11-7 win in the finals. Eli found himself trailing 7-4 going into the third period of the championship match with Gardner. Eli's conditioning and 'grit' proved to be the difference as he scored seven points in the final two minutes to win the championship."

For his performance, Eli Bozarth was named Norton's junior varsity "Wrestler of the Week".

At 152 pounds, Rylee Stanley

pinned Trevor Combs, Fleming, in 1:17; won a technical fall in 3:55 over Orrie Millberger, Axtell; pinned James Ramley, Atwood, in :55 and was pinned in 1:17 by Travis Pieper, Eustis-Farnham.

"Rylee had another good outing with two pins and a technical fall," said coach Miller. "In the finals, he faced a 'pumped up' Travis Pieper of Eustis-Farnham. Pieper is a senior and was going for his 100th career victory and was able to catch Rylee in a first period throw to his back for the fall. Pieper was voted the 'Outstanding Wrestler' of the tournament."

Taylor Gordon was in a 103 pound bracket with Wyatt Kipp, Arapahoe, who beat him with a technical fall in 4:54 of their finals match.

"Taylor has met Kipp several times the past two years and continues to make strides against him," said coach Miller. "At times, Taylor had Kipp frustrated but came up short in this best two out of three bid."

Cody Ellis was pinned in 2:36

of his first 130 pound match with Khy Rigel, Fleming, then lost a technical fall in 4:58 to Alec Ibach, SEM.

At 140 pounds, Jared Bohl lost a 5-4 decision in overtime to Thad Reiman, Elwood; pinned Garth Drier, UJV, in 2:46; was pinned in :13 by John Frerichs, SEM, and was pinned in 1:24 by Mitch Vanduren, Fleming.

"Cody Ellis and Jared Bohl faced some stiff competition," said coach Miller. "Although they may not have been particularly happy with their performance, they are continuing to try the things that we are stressing in the wrestling room. Today, they wrestled some more experienced upperclassmen."

**Next action**  
Norton will dual Ellis and Plaville in varsity action in Ellis today, beginning at 5 p.m.. Some junior varsity wrestlers could see some action.

Both the Norton varsity and junior varsity will wrestle in the annual Panther Classic on Saturday in Phillipsburg, beginning at 9 a.m.

A new book authored by Steven Michael Farney and entitled "CLUB 50" celebrates the Kansas high school boys basketball players who scored 50 or more points in a single game.

Featured in the book are stories on Norcat Cardinal Gary Ritter and Clayton Bulldog Dale Brooks. On February 10, 1967, Ritter scored 50 points in a game against Alton. Brooks tallied 56 points in a game versus Lenora on February 10, 1953.

Former Hill City player Gene Dodd is also featured. On January 9, 1970, Dodd hit 53 points in a win over Victoria.

The hard-bound, 172 page book details the basketball stories of 72 players from 62 Kansas schools who had these amazing scoring totals in a single contest.

Beginning with the 1921 season, the stories span the Sunflower State. Individual photos, team photos and statistical information are also included for each player.

"CLUB 50" also contains an interview with the national record holder, Danny Heater, who scored 135 points in one game on January 26, 1960.

In addition, the book lists 565 Kansas players from 272 schools who scored 40 or more points in a single game. Players from Hill City, Hoxie, Clayton, Norcat, Prairie View, Logan, Long Island, Selden, Herndon and Atwood are included.
