

Walk Kansas 2010 to begin in March

Walk Kansas 2010 begins March 7 and continues through May 1. It is a K-State Research and Extension health initiative and is in its ninth year. Many changes are taking place on the K-State campus, including the beginning of a new university administration under President Kirk Schulz. He and his wife, Noel, are joining the effort to support healthier lifestyles. Kirk and Noel invite you to join them as they participate in their first Walk Kansas.

Walk Kansas is offered in almost every county across the state. For more information and to request registration material, contact your local K-State Research and Extension Office.

Co-workers, family members, friends and neighbors form teams of six people who will track minutes of physical activity and food choices during the eight week challenge.

Physical activity for Walk Kansas is reported in minutes, which is consistent with the Physical Activity Guidelines from the U.S. Department of Health and Human Services. The recommendation is 150 minutes - 2 1/2 hours - per week of moderate to vigorous physical activity.

Remember, team members may, but do not have to, exercise

at the same time. Exercise may be done as an individual. To find out what other physical activities will be counted, you may contact the Extension Office or pick up a team packet and you will find a list of approved activities in the packet.

There is no reason to wait until March 7 to get back to your activity routine., Take a pair of walking shoes to work and go for 10 minute walking breaks in the morning and afternoon. If you have been a team member in the past, step up to become a team captain and invite people who have never participated before to be your teammates. Let's make this a great Walk Kansas Year.

Registration is due back in the Extension Office by March 5.




