The program will run from 1:00 p.m. to about 4:00 p.m

Bob Wold, K-State Extension Engineer, will present the program on the following topics: Nozzle type discussion and demonstration, calibration scenarios, droplet size discussion (coverage versus drift, calibration), Review of studies on efficacy and drift, and new technology.

An actual spray demonstration table will be in use. Applicator re-certification will be available for the following for three hours

each: Agricultural Plant, Right of Way, Industrial Weed and Noxious Weed.

K-State Research and Extension and Twin Creeks Extension District are sponsoring this event. There is no cost but we do ask for a pre-registration to be called into the Extension Office at 785-877-5755 by Feb. 16th.

We must have ten people preregistered to conduct the class.


