State-wide court furloughs set

The Kansas Supreme Court has issued an order calling for involuntary unpaid leave for court staff throughout the state's judicial districts on four Fridays in April and May.

The furlough time is not as extensive as first anticipated Justice Lawton R. Nuss wrote in a letter to court employees on March 12. He said the courts had been looking at two days a week for all of April, May and the first Thursday and Friday in June. The furloughs affect all judicial staff except judges and justices.

The 17th Judicial District covers six counties including Norton, Decatur, Phillips, Smith, Graham and Osborne counties.

Janelle Morel, administrative assistant for the 17th district, said 19 employees will be furloughed.

"It's all non-judicial employees," she said. "There's a total of six full time employees that will be

affected in Norton County," said Judge Deborah Anderson, district magistrate judge in Norton County.

Morel said they were fortunate to be down to four

furlough days. More days had been possible.

The difference in days is a result of other budget cuts the judicial branch has made and more money coming in from other sources, Nuss said. The judiciary has a hiring freeze that began in December of 2008, resulting in 100 vacancies, and has eliminated temporary hours of 193 employees who were performing necessary services, restricted travel and got approximately \$800,000 in federal stimulus funds through a grant program.

Controlled fire burns 600 acres

On Monday, the Norton Rural Fire Department responded to a fire 4 miles south of Norton that had started as a prescribed wildlife management burn.

According to Steve Otter, Rural Fire Department chief, the fire burned 600 acres on Norton Wildlife property south of Norton.

It started as a prescribed burn early Monday morning to burn off extra foli-

He said the fire quickly spread out of control when the wind changed and

burned Kansas Department of Wildlife and Parks land and a private homeowner's pasture.

Otter said seven trucks and 11 firemen from the Norton Rural Fire Department responded at 1:15 p.m.

At 2 p.m. Otter called for mutual aid from the Lenora Fire Department and for extra water resources.

The Almena Fire Department also responded. The Norton County Road and Bridge department provided two

Governor signs bill allowing an increase in county debt

SB 463, the bill allowing Norton County to increase their debt limits, was

signed by Gov. Parkinson on March 26 and makes Norton County one of three counties in the state to have a 30 percent debt limitation.

Norton County Commissioner Carolyn

Applegate said the current valuation of Norton County is \$38,980,437 making the 3 percent bond indebtedness limit \$1,169,413.10.

Under the new law, the indebtedness limit was increased to 30 percent, making the limit \$11,694,131.

Increase in scams reported

The Norton Police Department reported that at least six scams in the last four weeks are targeting people in Norton through mail and phone calls.

"They're all similar in that they want bank account information," said Officer Asa Stiles.

Stiles said people should not give out account numbers over the phone or deposit unknown checks into bank

He said people should close their account immediately if they think they have been the victim of a scam.

"So far, we haven't lost much money, but it's extremely hard to prosecute," Stiles said.
