## **Business in the spotlight**

Thanks to Norton City/County Economic Development, Mark Baker was able to start his tree service business three and a half years ago by taking over an existing business that was closing.

Mark said he has been interested in this work since he was a child picking up branches for his neighbor when he cut down trees. He always thought it looked like fun and he likes cutting things up. He also noted that there was a real need for this business in Norton area. Their sons, Nathan, 18, and Jordan, 13, help Mark with the business. Nathan is in college at Goodland but will be working with him full-time this summer. Mark and his wife have two other children, Marissa and Noah.

Mark fondly remembers one of his first jobs that involved doing some work on a giant maple tree. It was a touchy job, but he was able to remove a limb without damage to the house, garage or yard.

Wind and ice storm damage

so he does his tree service work on weekends and after hours. In winter, due to the weather and early sunset, the work tends to be somewhat seasonal, however he works anytime the weather is agreeable. During the summer, he and Nathan work until sunset and often later if there are limbs that can be loaded by truck lights.

Currently he does tree removal, stump removal and tree trimming. Future plans include the purchase of a larger stump remover, a tree lumber. He is able to do most of his own mechanical work and keeps all his equipment in good repair. One piece of equipment he uses was made in 1953.

Mark said they are 'all about safety' and don't take on more work than they can handle, although they are currently at the mercy of the weather and have some jobs waiting for them.

The economy of Norton County has slowed down, but he feels it will make a comeback.

# **Cow-calf seminars** focus on profitability

The Kansas Livestock Association and Intervet/Schering-Plough Animal Health will host three cow-calf profitability seminars during April. These seminars are designed to help ranchers address the challenges of today's beef industry, including instability in the marketplace and increasing regulations, by providing practical management information that can be applied to any operation.

Minimizing risk is more important than ever in the current environment of volatile markets. Management and marketing decisions that have worked in the past may not be the best options today. Kansas State University ag economist Michael Langemeier will provide suggestions on how cow-calf producers might be able to reduce risk and improve profit potential by using practical management methods. Intervet/ Schering-Plough Beef Cattle Technical Service Manager Eric Moore, DVM, will take it one step further by explaining how producers can increase value and efficiency through health programs.

Kansas Livestock Association Vice President and General Counsel Allie Devine, Assistant Counsel John Donley and Senior Vice President Mike Beam will discuss the current political and regulatory environment. The panel will provide information to cow-calf producers regarding regulations being discussed in

Washington, D.C., including those pertaining to air and water quality, and how their livelihoods could be affected.

The seminars will take place April 13 at the Huck Boyd Center in Phillipsburg; April 14 at the 4-H Exhibit Building in Holton; and April 15 at the Kingman Christian Church. Each seminar is free and will begin with dinner at 6 p.m. Those wanting to attend can find more information and a registration form at www.Kansas LivestockAssociation.org/calendar. The registration deadline for all three seminars is April 8.




