A hospital is more than a place where people go to heal, it is a part of the community that fosters health and represents hope. From providing treatment and comfort to the sick, to welcoming new life into the world, hospitals are central to a healthy and optimistic community.

That's the message organizers are touting with the 2010 National Hospital Week theme "Health, Hope and Healing." The event theme is the centerpiece of a promotional campaign aimed at uniting health care facilities across the country during the May

9–15 celebration.

"National Hospital Week, first and foremost, is a celebration of people," Rich Miller, administrator/CEO of Norton County Hospital, said. "We're extremely proud of each member of our staff and we recognize the important role they play in extending a sense of trust to our patients and our community."

One hundred thirty-two employees keep Norton County Hospital and the Doctors Clinic running.

Norton County Hospital is a critical access hospital comprised of a 25-bed acute care hospital, and also includes a rural health

clinic. The hospital has served Norton and the surrounding communities since 1945.

The nation's largest health care event, National Hospital Week dates back to 1921 when it was suggested by a magazine editor who hoped a community wide celebration would alleviate public fears about hospitals.

The celebration, launched in Chicago, succeeded in promoting trust and goodwill among members of the public and eventually spread to facilities across the country.

A full slate of activities for the hospital employees is planned for the week.

Melissa Baker, Northern Valley instrumental music director, has announced the beginning of an instrument drive, "Old Horns for Young Hands."


"There has been a good deal of


