Speedway hosts third stock car race

Special to The Telegram Brian Conness of WaKeeney and Norton's Kelly Karnopp were the hot drivers in their respective divisions at Elmwood Park Speedway in Norton Saturday evening.

Wade Wagenblast led the opening lap of the IMCA Northern Sport Mod feature before Troy Attwood took over on lap two. Then point leader Conness made the pass on Attwood the following lap and led the remaining distance to go 3 for 3 at the halfmile oval this season. Wagenblast settled for second, followed by Troy Robinson, Tyler Watts and Mathew Crowell. Conness also won the heat race.

Karnopp picked up his second win of the season at his hometown track. Karnopp passed early leader Rhett 'The Rocket' Kingsbury on lap four of the 12-lap IMCA Hobby Stock feature and was first to the checkers in the caution free race. Josh Latka got by Kingsbury to finish in the runner-up spot,

with Cody Graham and Jeromy Wagner rounding out the top five. Heat race winners were Graham and Karnopp.

Norton's Jason Davis won the 20-lap IMCA Stock Car feature in a close race over Colton Osborn and Cory Struckhoff. Chase Conaway led the first five laps before he spun to bring out the first caution and a spot at the end of the line on the restart, and giving Davis the lead. The caution flag waved on the next two laps, but Davis held on to the top spot. Osborn and Struckhoff chased Davis the last half of the race but had to settle for second and third respectively. Dustin McClurg and Dan Lauer finished fourth and fifth. Osborn and Davis were victorious in the two heat races.

Beloit's Tim Watts led from green to checkered in the IMCA Modified feature. Heat race winner Jerry Teel was second and Rick Schwab was third.

Veteran driver Bill Hays of Edison, Neb., led all 12 laps of the 305 Sprint Car feature. Point leader Randy Bantam was second and heat race winner Justin Schwien third. Howard Van Dyke finished fourth.

Racing action returns to the half-mile oval on June 12. The regular five classes will return to action with the green flag flying at 6 p.m.

Northern Valley, Logan thinclads qualify for state

nortontelegram@nwkansas.com Seven athletes from Logan High School and five from Northern Valley High School qualified for the State Track Meet during the Class 1A Regional Track Meet in Hays on Friday.

The Northern Valley boys placed eighth out of 23 teams with 24 points and the Logan boys finished 11th with 22 points.

The boys champion was Ness City with 132 points, followed by Quinter, 56; Quivira Heights, 45; Little River, 42; Tribune, 39; Victoria, 36; Palco, 30; Northern Valley, 24; Sharon Springs, 23; Natoma, 22; Logan, 22; Wheatland-Grinnell, 15; Claflin, 14; Hoxie, 14; Golden Plains, 11; Brewster, 6; Western Plains, 6; Otis-Bison, 5; Chase, 4; Triplains,

Austin Herman qualified for state competition with a runnerup spot in the triple jump with a personal best distance of 42'9".

Also qualifying for the state meet this Friday and Saturday in Wichita's Cessna Stadium was Matt Dole with a fourth place in the pole vault with a 10'6" clearance.

"Matt Dole's fourth place finish in the pole vault got the meet off to a good start for us," said Northern Valley coach Chuck Fessenden. "Matt came into the meet seeded sixth so this was a pleasant surprise.

"Austin Herman jumped a personal record 42'9" in the triple jump.

"Our 3200 meter relay team ran an outstanding time but missed qualifying for state by 64 hundredths of a second. The time they ran is currently the sixth best time in the state and would have won the other three regionals. Colton Lowry anchored the relay with a 2:01.3.

coach Chris Graham. "Brady Tien had another good day in the pole vault. Brady qualifying for state in the 100 meter dash was a nice surprise. We thought he had a chance but that race is kind of a toss-up sometimes.

"Tyson Pabst had a disappointing preliminary race in the 110 meter hurdles but came back and set a personal record in the javelin to qualify for state.

The Lady Trojans' Hannah Pinkerton won the silver medal with a runner-up finish in the pole vault with a clearance of 8' and Caley Greving made it in the shot put with a heave of 34'5" for fourth place.

Caley, Whitney Mulder, Paige Buss and Alethea Bennett also qualified for the state meet with a runner-up place in the 4 x 100 meter relay with a season best time of 52.67. Also just missing a state track meet performance was Dawn Archer, who finished fifth in the 400 meter dash in 1:05.8.

Megan Cole finished just behind sister Alison in the high jump with a 4'8" clearance to place fourth and also qualify for state competition.

Kayla Field Lowry just missed a state meet berth when she tied for fourth in the pole vault with a 7'6" clearance and was edged out on a jump off.

"The same thing happened to Kayla last year in the pole vault," said coach Fessenden. "She improved her height by six inches this season.

"It was nice to see both Megan and Alison qualify for the state meet in the high jump. Neither one of them jumped their best but we were happy to see both of them make it to state. Alison picked up a fourth place finish in the hurdles. Alison is a three-stepper and she was affected by the wind but she was able to hang onto fourth."

Jon Compton and Tyler Montgomery picked up some unexpected points for us," he said.




