Griffiths used her outfit as an example.  
She said she bought the pants on sale from Dillard's and her shirt from Ebay.  
Cindy Boller, owner of Destination Kitchen, said they knew the Internet was going to be their biggest competitor when they opened.  
"Our biggest competitor is the Internet. That's not going to go away," she said.  
Boller pointed out that Norton is a small town, and that they knew they needed to draw shoppers from a 90 miles radius if they were going to make it.

"We never thought, not once, that Norton would support us. You have to draw from other places," she said.  
Elaine Mann said she has worked in retail, the chamber of commerce and has held board positions on economic development and the school board.  
She emphasized the need to have a clothing store.  
"I have a great interest in Norton, and I have faith in Norton," she said.  
"I want to see this thing up and going. I urge you to do something," she said.  
Norton County Commissioner Carolyn Applegate spoke briefly

about the need to have a clothing store downtown, especially since Norton is growing with the Northwest Tech campus coming to downtown Norton, and the expansion of the Colby Community College nursing program and Natoma.  
"Don't just look at an aging community. Look at the young blood we're bringing in," Applegate urged.  
Audience members discussed some of their concerns, such as the need to have a service to bring people into the store as well as the effect of the Internet.  
Stiles said a scrapbooking store in eastern Kansas does 80 percent

of their business through their Web site.  
"We need to be online. Rather than see it as a negative, we need to use it," she said.  
Stiles asked those in attendance to fill out a survey to express their interest in being an investor, board member or volunteer. She said another meeting would be scheduled.  
"The purpose of this meeting is to determine the need to develop an additional clothing store. This has been a discussion we've had with business owners for the past 5 years," she said.
