Moran introduces legislation to preserve tall grass

Congressman Jerry Moran presettlement tallgrass prairie is also an important component in introduced legislation this week, H.R. 5118, the Flint Hills Preservation Act, to protect the ability of landowners in the Flint Hills to use prescribed fire as a tool to preserve the tallgrass prairie ecosystem.

The Flint Hills region of Kansas and Oklahoma contains the world's largest share of remaining tallgrass prairie and is the only place where that habitat exists in landscape proportions. Only 4 percent of North America's survives to this day, and 80 percent is located in Kansas.

Each year, ranchers, landowners and conservation groups use prescribed fires to mimic the seasonal fires that have shaped the tallgrass prairie for thousands of years. Prescribed burning is an essential management practice for protecting the ecosystem, enhancing grazing land and reducing the chances of destructive wildfires such as those in California and other states. Prescribed burning ranchland management. It helps ranchers keep pastures free from invasive species, like eastern red cedars, and leads to higher quality grass that increases weight gain in their cattle. Last year, a condensed timeframe for grassland burning caused heightened air quality readings in Kansas City and Wichita. As a result, the Environmental Protection Agency is seeking to regulate how and when landowners can burn in the Flint Hills region by asking

the state of Kansas to develop a smoke management plan. H.R. 5118 recognizes that prescribed fires are a necessary and natural phenomena. It exempts landowners and local governments from Environmental Protection Agency enforcement of Clean Air Act standards, if the enforcement action is attributed to smoke from prescribed fires in the Flint Hills region.

'The Flint Hills region is one of the last contiguous stretches of the tallgrass prairie in the United

States. It is disappointing that Moran's initiative to correct a the Environmental Protection Agency would try to disrupt a vital management tool like prescribed fires," said Moran. "This legislation will allow landowners to preserve a unique ecosystem and manage prescribed burning around the forces of weather and other factors impacting safe conditions, without worrying about a schedule dictated by some Environmental Protection Agency bureaucrat in Washington."

"We applaud Congressman

flaw in the Clean Air Act with this legislation," said Kansas Livestock Association President Mark Smith. "Prescribed burning in the Flint Hills is a proven, economical tool that protects and enhances the tallgrass prairie. Smoke that results from this practice should not cause regulatory compliance problems for our urban neighbors."

The council asked Lawson if the position had been budgeted. He said it hadn't, but there would be one less summer employee.

"I think we can make it work," he said.

Lawson said there were three applications turned in. A motion was made to approve the recommendation of Ted Hull. Vote taken, motion passed.

· Lawson said the water clarifier is down at the water treatment plant. He said plant employees have done some repair work to it.

Lawson also reported that Carol Griffey retired from the power plant. He said the plant can't keep up with 24/7 shifts and asked the council to make a motion to get rid of the night shifts and transfer the crews to the day shift. He said the employees would work on securing the building, with access at night being eliminated except by power plant employees.

"We're not closing the plant down," he said.

A motion was made to transfer the night crews to the day shift. Vote taken, motion passed.

• Donna Foley reported on the last safety committee meeting. She said they met with Judge Hawks to discuss records and court costs. Foley made a motion to have all court cases entered into the computer by August and eliminate hand written forms. Vote taken, motion passed.

Foley made a motion to have court costs increased to \$1 to offset state costs. The council discussed the issue and whether costs should increase by \$1 or \$5.

"I would go to \$5," Snyder said.

Toby Kuhn said crime will not be deterred by increased fines.

"The costs have increased dramatically since 1995," he said. Foley said she wanted to keep

up with costs from the state, not fall behind. Vote taken, motion passed to

increase court costs by \$1. Foley also discussed the house arrest system. She said the city has two house arrest bracelets, which are an option for people sentenced to serve jail time. The bracelets require payment up front, and Foley said a payment plan would make them more accessible.

A motion was made to offer a payment plan for the house arrest bracelets. Vote taken, motion passed.

Foley said many people choose jail time over being under house arrest because it is free. She said she wanted to offset the difference by charging \$52 a day to people incarcerated in the county jail. City Attorney Karen Griffiths said she would have to research that before it could be voted on.

• Snyder made a motion to approve the purchase of a building from KowPoke for the water treatment plant. Lawson said it would be similar to a carport. The cost was estimated at \$3,900. Vote taken, motion passed.

· Corina Cox, Northwest Kansas Planning and Development, was present to hold the public hearing for the CDBG grant.

The grant will fund a new fire truck, a project that is estimated to cost \$331,700. There were no public comments.

• A motion was made to approve a \$500 donation to the Norton Area Chamber of Commerce's July 4 fireworks display. Vote taken, motion passed.

• A motion was made to go into executive session for 15 minutes to include the mayor, city attorney, city administrator and city clerk. Vote taken, motion passed. The council returned to open meeting with no action taken.

The next Norton City Council meeting will be held June 16 in the city office.

The Department of Wildlife and Parks has the contract for the cabins, which cost an estimated \$30,000 in materials per cabin, he said.

Prairie Dog State Park Manager Toby Kuhn said the park currently has two primitive cabins, and the two modern cabins will be installed on the road going towards the public fishing dock. The first cabin was installed several weeks ago, but it has not been hooked up with utilities.

Kuhn said a contractor will finish the utility work. Each cabin will have a water line, he said.

"We'll have a total of four cab-

ins. They'll be open year-round," Kuhn said.

Kuhn said he wasn't sure when the cabins would be open. The contractor has to finish their work before Wildlife and Parks can pour concrete for patios and do other maintenance.

Prairie Dog's four cabins, primitive and modern, will be open year-round.

"They're going to be very popular based on the number of calls we've received," Kuhn said.

Jansonius said there are currently two more cabins under construction. One will go to Webster, and the next two will go to Jamestown.
