FSA acreage certification deadline

It's time for the Norton County risk. FSA Participants to certify feed grains and Conservation Reserve Program acres to your local FSA

Certification is the reporting of planted crop acreages and land uses, as well as crop shares and planting dates.

Various programs approved by this farm bill have specific acreage reporting requirements.

ALL cropland and/or non-cropland on a farm must be reported to remain eligible for certain Farm Service Agency Program Benefits including the Direct and Counter-Cyclical Program (DCP), Commodity Loans and Loan Deficiency Payments (LDP), the Conservation Reserve Program (CRP), the Non-Insured Crop Disaster Assistance Program (NAP) and the Supplemental Revenue Assistance Payments Program

Annually, FSA Participants are required to file an accurate acreage report. FSA Participants must supply the Norton County FSA Office with the following information when reporting acres: planted crop, intended use, practice, planted acres, planting dates and shares.

Crop shares must be reported the way the crop is actually divided and those shares must reflect how the farm program payments are divided according to acres at

prevented planted acres and failed acres in order to obtain crop history and eligibility for any permanent disaster programs.

Failed acres only need to be reported to FSA if the crop is going to be mechanically destroyed or replanted to a different crop.

Uninsured failed acres that will be planted to a different crop must be reported to FSA before the earlier of:

1) the failed acreage is destroyed or

2) acreage reporting deadline in order for the failed crop to receive planting history credit. Insured

It is important to timely report by the final reporting date and the insurance documents must be provided identifying the location and acreage of the failed crop. FSA Participants must complete a CCC-576, Notice of Loss for both prevented planted acres and failed acres.

If a FSA participant has certified acres with an insurance company prior to the FSA certification appointment, a copy of the insurance certification of acreage is beneficial in helping the FSA Office and your insurance provider match crop, acres and planting dates.

August 1st • Crops that are covered by NAP insurance must be reported by the earlier of: 15 days prior to grazing, haying or harvesting or the Aug.

1 deadline Acreage reports filed after the applicable deadline(s) will still be accepted, but late-filing fees (\$30 per farm plus \$16 per hour) are charged for field inspections and evidence of the crop must still exist.

Traditionally, the Fourth of July holiday creates one of the busiest travel times on roads and highways in Kansas. Unfortunately, an increase in traffic increases the likelihood of traffic crashes, injuries and deaths.

Kansas Department of Transportation travel information resources can help with planning your holiday or other summer travels and can keep you informed as you travel.

By planning ahead, travelers can find out if their routes are impacted by road work and make other plans as needed. With weather updates provided every 15 minutes, Kansas 511 can be a resource to help travelers learn about changing weather condi-

Before traveling, call 511 anytime from any phone in Kansas or 1-866-511-KDOT (5368) from anywhere in the U.S. to find out about the latest driving conditions, work zone and travel weather information for the Kansas Turnpike and any Interstate, U.S. or state highway in Kansas and Nebraska.

Phone numbers for road conditions in other states surrounding Kansas are provided. Information is provided free from a landline phone; however, for cellular phone users, cell minutes may apply.

Road information can be obtained by visiting the 511 Travel Information Map at 511.ksdot. org that now includes 33 cameras and 25 electronic message sign views across the state. The 511 map provides links to other information, such as closed roads and driving conditions lists, travel information for other states and more. These and additional traveler information can be viewed by visiting KDOT's new traveler information portal, KanDrive, at www.KanDrive.org.

En route travelers will be informed of road conditions and road closings by Dynamic Message Signs on I-70, extending from Topeka to Goodland, and on northbound I-135 and southbound US-81 in the north central region of Kansas.

In the Kansas City area, travelers can visit the Kansas City Scout Web site at www.kcscout.org for camera views and incident and message board information for many interstates in the Kansas City area.

Travelers can use their handheld mobile devices, such as Smartphones or Blackberries to access a text report for construction project information by visiting 511mm.ksdot.org.

If alcohol is going to be part of your holiday celebration, please don't get behind the wheel; plan ahead and use a designated driver. This travel season, state officials remind travelers to stay informed, wear their seat belts and watch out for motorcyclists and workers in work zones. 
