## Escaped inmate captured in Colby

Hutchinson Correctional Facility was gone for only a few hours before being captured in a Colby bar.

According to the Associated Press, Robert Nickelson, 44, escaped Sunday evening from a work-release program at a food plant in Chase, near Great Bend. He had been serving five years and six months for the rape of an exotic dancer in Topeka in 2000 and two years for conspiracy to commit rape.

At 11 p.m. that night, said Police Chief Randy Jones, the Colby Police Department got a call about a suspicious person at the B-Hive Bar and Grill.

The caller, an employee of the bar, said the man had been trying to sell a vehicle.

In a release, Jones said Officer Donnie Valles went to the bar and met the employee outside. Officer

A check of the license plate got a hit from the National Crime Information Center, Jones said. The truck had been reported stolen from Rice County with Nickelson listed as the possible driver.

The officers went into the bar and arrested Nickelson without incident. The chief said he did not give any information about himself but he was identified by photos sent out after his escape.

Nickelson was taken to the Law Enforcement Center and has been turned over to Kansas Department of Corrections officers, Jones said.
