
The total estimated cost of the emergency repair was \$841,411.

The election of officers and a review of the 2010-'11 school budget was the focus of the regular meeting of Norton Community Schools Board of Education on Monday.

Superintendent Greg Mann reported that no one had contacted him about the vacant board position.

"We will advertise again in anticipation that someone will step forward and be willing to serve on the board." said Mann said the City of Norton has

agreed to pay half the cost of the Versa system for the tennis courts and the company should begin work on the cracks on Wednesday. He reported that he would be taking the budget to Topeka on Thursday for review.

The budget will need to be published by July 30 in order to have the hearing on Aug. 12.
