# Top employees are honored at Norton Correction Facility

Congratulations are in order for COII Lawrence Randall, CCII Terry Petrie, and Aramark Food Service Manager Janine Gruwell, on their selection as Norton Correctional Facility's Employees of the 1st Quarter in 2010.

**Uniform Employee: COII** Lawrence Randall started his Department of Corrections career as a COI at the East Unit in November 1988. In May of 1989 he was promoted to COII, where he began working on work crews. Larry has been involved with improvements in many communities due to his assignment on work crews. Upon the 2009 closure of the East Unit, Larry transferred to the Central Unit where he was also assigned to the work crew detail. During this 21+ year career with Department of Corrections, he has received numerous letters of commendation for his supervision and work performance of his work detail.

Larry is very conscientious and has a keen sense of attention to detail when working. This is especially important when performing work out in the public eye. Larry enjoys working for the various communities in our area and recently stated that it gives him a sense of pride and accomplishment when he can see how the work he and his details benefit our small communities is a positive manner. Some of the many communities and small organizations that Larry has received letters of recognition from are Prairie Dog State Park, Phillipsburg Rodeo Association, Logan USD 326, The Boy and Girl Scout programs in Plainville, Kirwin Wildlife Refuge, Webster State Park, City of Plainville, Plainville Ambulance Service and the Plainville Police Department.

Non-Uniform Employee: CCII Terry Petrie began his employment with Norton Correctional Facility in August 1992 as a COI, promoted to COII in August 1994, CCI in March 1999 and then to his current position of CCII in June 2007. Terry does a great job as a Unit Team member at Norton Correctional Facility and he juggles many additional responsibilities in addition to his regular job duties.

Terry has been through Trainer of Trainer classes and teaches an OMIS training class and the Criminal Justice System to new officers. CCII Petrie became a member of the Norton Correctional Facility Crisis Resolution Team in 1998 and has served as coordinator of this specialized team for the past two years. This involves developing, planning and initiating drills and training associated with response to potential emergencies within Kansas Department of Corrections facilities and the public sector.

Norton Correctional Facility recently had a critical situation develop that involved a highly volatile inmate climbing onto a three story building and threatening to jump from the roof. Over a period of three hours, CCII Petrie was able to coordinate a negotiation team where he served as the primary negotiator, working with a secondary negotiator, and the team was able to de- escalate this emergency, resolving it with a very positive outcome. He was able to rely on and utilize his training as the Crisis Resolution Team coordinator to establish positive communication with the inmate, convincing him to come down from the roof of the building, with no injuries being sustained by the inmate or staff.

Contract Employee: Janine Gruwell, Aramark Food Service Manager, began her employment with Norton Correctional Facility in January 1992 as a temporary Office Assistant. In November 1991 she was hired as a Food Service Supervisor where she worked until Food Service was privatized. Janine was hired as the Aramark Food Service Manager when Aramark assumed the contract, where she remains.

Janine manages her staff and a large number of inmates providing three meals a day to over 700 inmates with very few complaints or interruptions. Janine and her staff worked diligently with Security, Maintenance, and Work Crews to open the new dining hall which went very smoothly and with very few complications. Janine's ability to work as a team player should be commended.

## Drunk driving laws are enforced

Kansas law enforcement agencies have seen enough. Enough people killed and maimed by impaired driving. So they're cracking down, in Kansas, and a lot more people are going to find themselves wrapping their hands steering wheel.

Under Kansas law, all impaired drivers go to jail. The minimum sentence is two days; the maximum is six months.

Law enforcement and public safety officials gathered Aug. 12 in Wichita to discuss upcoming enforcement efforts that will put more offenders behind bars.

Whitney Williams, a teenage student whose father was killed in a crash caused by an impaired driver, was featured speaker. Whitney, a 2010 graduate of Wichita Northwest High School, is a volunteer with the DUI Victim Center of Kansas and will enroll at Cowley County Community College in August.

Two senior officials from the Wichita Police Department, Deputy Chief Terri Moses and Lt. Joe Schroeder, also spoke at the event. Moses discussed the role of the public in supporting law enforcement efforts to save lives. Schroeder discussed an internal impaired-driving task force he is leading for the department and the formation of a regional cooperative effort involving multiple law enforcement agencies in southcentral Kansas.

Pete Bodyk, traffic safety manager for the KDOT Bureau of Transportation Safety and Technology, highlighted the statewide "Drunk driving. Over the limit. Under arrest." crackdown. Starting Aug. 20 and continuing through the Labor Day weekend, Kansas law enforcement agencies will team up with law enforcement and highway safety agencies across the nation in the annual DUI enforcement mobilization.

Whitney, 18, lost her father in Sept. 2008. He was riding a motorcycle when a driver who had been

drinking ran a red light and hit him. She talked about the lifelong toll impaired drivers take on families of their victims. As a volunteer with the DUI Victim Center, she speaks frequently on the topic.

"If I can change one life by around jail cell bars instead of a talking about what happened to me, and get them to change their behavior - just one - it will be worth it," she said.

> The media event took place Aug. 12 at Wichita Police Headquarters, Wichita, immediately following the daily Interwatch Briefing.

> Alcohol-related crashes are usually more serious than those not involving impaired drivers. In Kansas, impaired driving accounted for only 5 percent of all crashes in 2008, but 34.5 percent of all fatal crashes.

Statewide in 2008, the most

recent year for which data is available, there were 3,366 alcoholrelated crashes that resulted in 131 deaths and 1,999 injuries. There were 120 alcohol-related crashes that caused the 131 deaths; of those 120 crashes, half (59) involved drivers between the ages of 20 and 34. Of the 120 impaired drivers, 105 were male and 15

were female. The national "Drunk driving. Over the limit. Under arrest." crackdown, organized by the National Highway Traffic Safety Administration, combines high-visibility enforcement with heightened public awareness ef-

It is designed to put all drivers on notice that if they are caught driving impaired, they will be arrested.
