

August tag renewal coming to an end

The last day for businesses or persons whose name begins with "M", "N" or "O" to renew automobile, light trucks, motorcycles and/or motorized bikes tags at the Norton County Treasurer's Office will be August 31, 2010. When renewing your vehicles remember to include your current proof of insurance. We need to verify the VIN number, policy number and expiration date. In addition to insurance we need your driver license number or Federal ID number for the business.

Driver license renewals can be done Tuesday through Friday from 8:00 a.m. to 4:00 p.m. Instructional permits (IP) and Driver Education restricted licenses can be done in the office by appointment only. You will need to bring an original state issued certified birth certificate, social security card for the applicant and a utility bill with current address plus the driver license of the parent that brings the child.

New medical clinic underway

The upcoming months will usher in a new look for Norton County Hospital, which is constructing a rural medical clinic adjacent to the southwest side of the existing hospital facility. The \$2.5 million project will consist of the construction of 9,000 square feet of clinic space, the renovation of a small portion of the existing hospital, and the construction of new off-street parking and sidewalk system. Construction began this week, and is expected to be complete in the spring of

"The expansion and improvements will not only provide patients with a more convenient clinic visit, but the connection of the clinic and hospital facilities will help our medical service providers offer their exceptional care in a more efficient and effective manner," said Rich Miller, Norton County Hospital Administrator.

Currently, there are four physicians, three mid-level health care providers, and many additional health care professionals working from the Doctors Clinic building constructed in 1962 and located one block from the hospital campus. New clinic construction plans were based on the needs for a physical connection between the clinic and the hospital facilities, additional exam rooms and office space, enhanced accessibility and additional parking.

Once clinic operations begin at the new location, Colby Community College Norton Annex will relocate into a portion of the existing clinic building. There they will have space needed to allow for increased teaching staff and enrollment at their nursing school.

Consulting architects, Health Facilities Group, Wichita, have been working on the clinic design for several months.

While working on the design phase, the hospital has been successful in securing a combination of USDA Rural Development and other financing sources for the project.

Murray Company, Overland Park, has been hired to provide Construction Management services for the project. Murray Company has been involved in two previous hospital construction projects.

During construction, the hospital's south parking lot will be closed. Parking for the Physical Therapy and Cardiac Rehabilitation departments will be affected. Throughout the construction phase, all patients and visitors are asked to park in the main parking lot.

Updates for the Norton County Sheriff's Dept.

Norton County Sheriff Troy Thomson wants the county to go from hand-written complaint cards to having daily logs and complaints logged on a computer.

So he went to visit will the Norton County commissioners on Monday to talk to them about a grant application that would allow his office to modernize

The grant, he said, would help pay for upgrades to the dispatch center and would include computer generated complaint cards, daily log cards and a records management system. At this time, the system is done by hand-generated cards, which is both time consuming and hard

The grant will be applied for through

Road and Bridge Supervisor Tom Brannan talked about equipment service and repair and gave the commissioners an outline of what he expects in the way of repairs over the next few months and how much each should cost.

Mr. Brannan said that bridge construction is proceeding nicely with OS125 and that work on the bridge itself should be completed next week. The decking, rail and dirt work should be done by the end of the week, he said.

He also gave the commissioners an update on what was happening to a motor grader, which had been damaged by fire. Mr. Brannan said that the grader has been sent off to a larger company facility

The West Washington Road work is near completion, he told the commissioners. However, he said, he is not happy with a stretch of the millings and has plans to go back and reduce a section to improve the compaction on the street. Without proper compaction, the street will not hold up as

Curt Archibald, Norton County Solid Waste supervisor, reported that Whitney Construction will begin work on a pit extension at the land fill this week. The contract for the extension was approved by the commissioners a month ago, he noted, and will include the construction of a new construction debris pit as well.

Mr. Archibald said that he will also be delivering recycling bins to the school (**Logs** - Continued on Page 5)

Sick Kentucky horse recovering in Norcatur

Rico, the three-year old Tennessee Walker stallion, that is making a cross-country trip with his owner, Don DelMonte, had a close call last weekend. He became "colicy," a shut-down of the digestive tract, and it was feared he might need surgery.

Mr. DelMonte and Rico have been on the road since March 5 when they left Lexington, Ky., headed for Los Angeles. The focus of their trip is to raise awareness for the prevention of child abuse and suicide prevention. The trip is in memory of Mr. DelMonte's 18-year old niece, Felicia Roberson, who committed suicide in 2003. He, himself, endured an abusive childhood, so the cause is a very personal one.

Horse and rider average about 20 miles a day and had expected to be out of Kansas by this time. However, Saturday evening, when they arrived at their scheduled stop in Norcatur at the Jim Plotts home, events took a turn for the worse.

When they arrived, it was discovered the horse had chipped a front hoof and the shoe was very loose. During the night it came off and a local farrier made an emergency house-call Sunday morning. During the day it became apparent that Rico was not feeling well and by night he was obviously in pain. Colic was suspected. It was about midnight when the decision was made to call Dr. Aaron White. Dr. White confirmed the diagnosis and after drenching Rico with mineral oil and giving him some fluids intravenously he recommended walking him to see if the condition would correct itself. If it didn't, he said the horse might need surgery.

Mr. DelMonte walked Rico all night with no results. So Monday morning, in a borrowed horse trailer, Mr. Plotts drove the two to Kansas State University and the School of Veterinary Medicine. Rico was examined by graduate veterinary students and interns. In an attempt to avoid surgery, he was given an injection to shrink his spleen which would relieve pressure on his intestines. Then the students took turns running Rico up and down an alley-way as fast as they could. That procedure achieved the results they had hoped for and Rico was released.

It was a tired trio that rolled into Norcatur about (**HORSE** - Continued on Page 5)
