Mr. Husted pled guilty to and was charged with conspiracy to commit unlawful sexual relations, a level 10 person felony and simple battery. He was sentenced to six months with the Kansas Department of Corrections for the first count and six months in the Norton County Jail for the second charge, both sentences to run concurrently.

He will be under the supervision of court services for 12 months. As a condition of his probation, he is to serve ten days in the Norton County Jail, to be done during vacation from school as he is attending Cloud County Community College.

Dan Bainter, Supervisor of Public Works, said, "The leak was large enough, that the water tank basically emptied in one hour."

City Administrator Rob Lawson reported on the water leak which occurred on Friday, Sept. 10. He stated a 12 inch water main broke at Madison and State Street. The leak was large enough the water couldn't be pumped to the tower fast enough and still maintain pressure throughout the city, so it drained the town. The City called Kansas Department of Health and Environment for assistance and advice. A boil order was issued by Kansas Department of Health and Environment for disinfection safety reasons. The county had two tanker trucks on standby for fire emergencies and the National Guard Armory provided water for residents to use for cleaning and flushing purposes. Sheriff Troy Thomson took care of the emergency management issues, Kansas Department of Transportation assisted with traffic control and fill dirt, and employees from several different departments worked on repairing the leak.

Lawson said the City took water samples to an independent lab in McCook, Neb. twice to be analyzed for coli form. The first set of four samples showed three were negative and one had a count of five parts per billion. Four more samples were taken on

and one had a count of one part Manor Board and other boards and per billion. The boil order was lifted on Tuesday afternoon by Kansas Department of Health and Environment after the required twenty-four hour water test. Both labs were closed on Sunday and Monday was the soonest water could be tested.

> Rob Lawson stated according to Section 15-202 of the Norton City Code, the city does not guarantee the delivery of water through any of its mains and connecting services at any time except only when its mains, pumping machinery and power service connection are in good working order and the supply of water is sufficient for the usual demand of its consumers. The break of the twelve inch main was beyond the city's control and everything was done to remedy the situation as quickly as possible.

> Dan Bainter said, "I want to thank all the crews and entities that helped with the water line break.'
