# Questions you always wanted to ask

Center is also known as the landfill. A new 5th cell was recently opened for household trash. Whitney Construction of Almena did the work. The bottom of the cell consists of a clay and Bentonite mixture compacted to help stop leachate water (water that seeps through the trash) from getting into ground water. A leachate collection system is in place to collect the leachate water in tubes and the liquid is then pumped back onto the trash to evaporate.

Recycling in Norton County has increased to 27%, however the the landfill anytime. rate would be much higher (and better for the environment) if evervone would recycle. Recycling accepted at the landfill includes plastic (look for the triangles: 1-7 are recyclable), newspapers, magazines, books, junk mail and tin cans. Please rinse out recycled cans and plastic containers. Cans and plastic containers that have not been rinsed out will contaminate the other recycling - please keep it clean. Remember to use blue or clear bags for recycling. Here is an example of questions received at the landfill and the answers provided:

The Solid Waste & Recycling als such as washers, dryers, hot water tanks, etc..

There were cans of paint in the garage when I moved in. Will you take it? The landfill accepts any kind of paint at no charge.

Can we bring out tree limbs and grass clippings? Yes, tree limbs and grass clippings are accepted at no charge.

When do you pick-up recyclables? Norton has curbside pick-up of recycling on Fridays; Almena and Lenora have curbside pick-up of recycling on Tuesdays. Recyclables can also be brought to

How much does it cost to bring trash to the landfill? Household trash(MSW) is \$.68 per 20 pound; C&D is \$.35 per 20 pound, white goods \$ .35 per 20 pound.

In 2009 the following volumes were processed:

2298.8 tons of trash. This represents 2.17 pounds of trash per person per day from Norton County residents using the landfill. 1305.1 tons of C&D, 37.75 tons of white goods, 642.7 tons of recycling

A trip to the landfill can be enjoyable if the waste is separated. Separating waste in advance will also save time.

### PUBLIC NOTICE **ORDINANCE NO. 2010-3**

Published in The Norton Telegram on Tuesday, September 21, 2010

#### ORDINANCE NO. 2010-3 AN ORDINANCE ESTABLISHING WATER RATES AND FEES FOR THE CITY OF CLAYTON, KANSAS AND REPEALING PORTIONS OF PRIOR ORDINANCES

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CLAYTON, KANSAS.

Section 1. That effective September 30, 2010, a minimum of \$30,00 monthly water service fee is hereby established which shall entitle the customer to 1000 gallons of water each month, and excess water usage above said minimum amount shall be charged on a basis of \$3.00 per 1000 gallons or portion thereof over said minimum quantity. A \$50.00 nonrefundable water tap fee for new water service and a fee in the same amount for restoration of service in the event water service has been terminated by reason of nonpayment shall apply, which water service fees shall become effective September 30, 2010.

Section 2. The previous Clayton City Ordinance No. 1993-1 as to Section 1 thereof is repealed as of September 30, 2010, and prior Ordinance provisions inconsistent herewith are repealed and modified as necessary in order that this Ordinance shall supersede conflicting Ordinance terms and provisions.

Section 3. This Ordinance shall take effect from and after its publication in the official city newspaper and the rates set forth in Section 1 shall be applied commencing September 30, 2010.

Passed and approved by the governing body of the City of Clayton, Kansas, this 13th day of September 2010.
