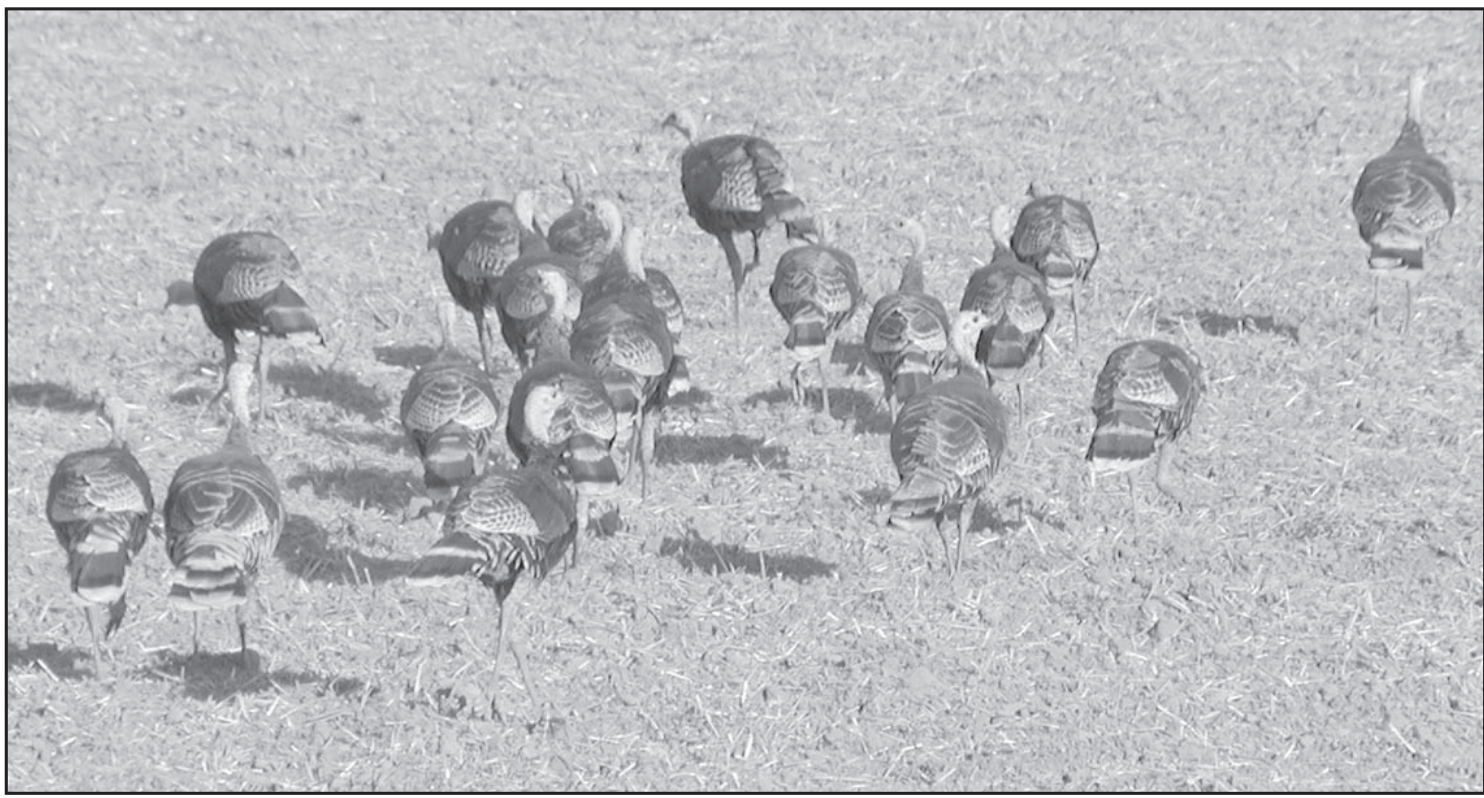


## Looking for the safest place!
