This was also just the second season that both Norton girls and boys qualified a team for the state meet in the same year. That happened last year for the first time ever when the girls placed third and the boys 11th.

"Alec Hager, Marc Miller, "The main reason our girls Kegan Vanover and John Renner students at Norton Community also ran their best times on this course.


'Troy Bainter's body just gave out on him but Troy showed why he is a true champion and competitor and finished the race.



RESOLUTION #2010 - 113

A RESOLUTION DECLARING CERTAIN PROPERTIES TO BE UNSAFE AND DANGEROUS

AND ORDERING THEIR REPAIR OR REMOVAL WHEREAS Ordinance #260, provides a procedure for ordering the repair or removal of dangerous structures; and,

WHEREAS, the enforcing officer has filed a statement with the governing body pursuant to Ordinance #260 declaring certain structures to be unsafe or dangerous: and.

WHEREAS, on September 30, 2010, the Norcatur City Council met and held a hearing after proper notice concerning making a determination of whether or not such structures were unsafe or dangerous,

NOW THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF NORCATUR, KANSAS, that:

Section 1: After hearing testimony from Jan Katz Ackerman, Code Enforcement Officer, the council finds that the property at 503 Opelik St. is unsafe and dangerous and orders the owner to repair or remove the structure within 30 days from September 30, 2010. If, at the end of 30 days, the property is not repaired or removed, the city will proceed to remove the property.

Section 2: After hearing testimony from Jan Katz Ackerman, Code Enforcement Officer, and the owner Rick Gienapp, the council finds that the property at 112 N. Dexter is unsafe and dangerous and orders the owner to secure the structure from the outside elements and clean up the debris on the property not later than January 1, 2011. If, at the end of that time, the property is not repaired or removed, the city will proceed to remove or repair the building.

Section 3: After hearing testimony from Jan Katz Ackerman, Code Enforcement Officer, and the owner Jim Plotts, the council finds that the property at 123 S. Decatur has been secured from the outside elements and the owner is given 30 days to finish up the tin on the back side of the building. If the repairs are not made by that time, the council will review the matter at that time.

Section 4: This resolution shall be published in the official city newspaper one time, and the enforcing officer shall mail by certified, restricted delivery mail, marked "deliver to addressee only" a copy of this resolution to each such owner, agent, lienholder or occupant of each of the structures described above. APPROVED BY the Governing Body on this 30th day of September, 2010.


