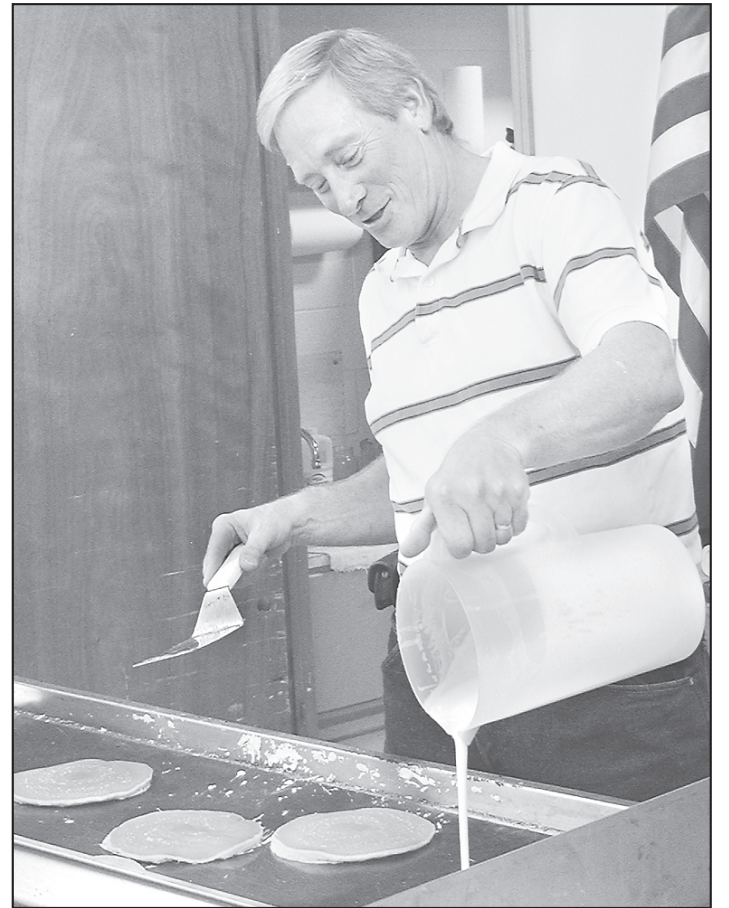

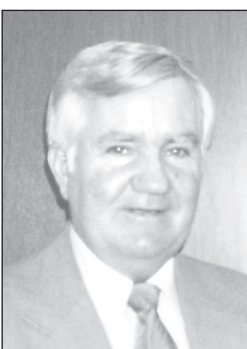
Wava Reames and her father, Frank Ward, attended the American Legion supper and membership drive.
