# Downtown district receives historic status

The nomination of the Norton Downtown Historic District to the National Register of Historic Places and the Register of Historic Kansas Places was approved by the Kansas Historic Sites Board of Review at its meeting Nov. 20 in Topeka.

While it received the designation to the state register last month, the National Parks Service will review the nomination to the National Register. It should be approved by the Parks Service by the end of January, said Kerry Davis, nomination preparer and owner of Preservation Solutions, LLC.

Preservation Solutions is an historic preservation consultant hired earlier this year by the Norton City/County Economic Development to prepare and submit the nomination.

The National Register lists historic properties worthy of preservation, but a listing doesn't mean limitations are placed on the property by the government or that public visitation is required.

The designation could mean tax incentives for businesses who wish to make improvements, Davis said in a phone conversation.

Having the entire district approved means that the whole group of buildings have passed the first step collectively; however, any improvements on each building will be considered separately because each has inherently different circumstances based on eligibility status, the level of work involved and whether they are income producing or non-profit

Some grants are available for rehabilitation projects, but they are highly competitive and usually go to public buildings such as courthouses, libraries and post offices, not to private properties, Davis said.

While the designation also means the district falls under the Kansas Historical Preservation Act which says that any work on a property within 500 feet of the historic district listing boundary that

# Commissioners pay bills

The Norton County Commissioners

met on Tuesday this week to approve payment of the end of the month bills. John Miller was absent. Ron Kent asked the commissioners for

millings to fill in where the road meets the driveway of his business Norton Ice. Commission Chairman Richard Thompson and Commissioner Carolyn Applegate agreed to the request.

Kent also told commissioners he needed an easement to cross a road in Cinema Hills twice to tie into the sewer. "Traditionally we don't have a problem crossing the road for utilities," said Norton County Attorney Doug Sebelius.

Thompson and Applegate authorized him to use a county easement but asked for paperwork identifying specific information.

Applegate mentioned that she had heard many comments about the lights that have been put up on the courthouse as well as Santa's house. Applegate said

there were many favorable comments Santa's opening night.

Cindy Linner, Norton County Treasurer, said sales tax collection was down \$3,000 from a year ago, when she gave her monthly report.

Sandy Smith, Road and Bridge Department administrative assistant, told the commissioners she would meet with Steve Berland about the bridge work that needs to be done before ordering supplies.

Her department is working on taking

inventory and organizing it. Smith asked the commissioners if it would be possible to purchase a 22-feet tilt top trailer to be used to haul the bobcat loader.

Workers currently have to use the large trailer or borrow someone's personal trailer if it's in use.

R.A. Peterson, D.C., whose term on the Norton County Hospital Board of Trustees will expire at the end of the year, met with the board to tell them he is interested in serving another term.
